# Instructions

If your Social Security Number or Juris Number are not entered in the spaces provided, please enter them. If either number is not correct, cross it off and write the correct number on the front of this return.

### Who Must File This Return

Any attorney listed on the roll of attorneys maintained by the Superior Court at any time during the calendar year for which this return is filed must file a return for that calendar year even if exemption from tax is claimed.

### Who Is Liable for the Tax

Any person who is admitted as an attorney by the judges of the Superior Court, and who engaged in the practice of law in Connecticut during the calendar year for which this return is filed and who is not exempt from this tax, is liable for the tax.

Any person employed as an attorney by an employer, where the employer is not a law firm but the position requires the person be admitted as an attorney by the judges of the Superior Court, is considered to be engaged in the practice of law and is liable for the tax.

## Who Is Exempt From the Tax

See Section I of this return for a complete list of exemptions.

## **Employers Paying on Behalf of Employees**

Employers paying the tax on behalf of employees must attach a list that includes each employee's name, Connecticut Tax Registration Number (if applicable), Social Security Number, and Juris Number. One check may be submitted for the total amount due.

#### When Do I File

File **Form 472**, *Attorney Occupational Tax Return*, on or before January 15, 2005.

#### What if I File or Pay Late

If you are subject to the tax and pay late, the late payment penalty is \$50. Late payments are subject to interest at the rate of 1% (.01) per month or fraction of a month from the due date to the date of payment.

If you are exempt from the tax but file Form 472 late, a late filing penalty of \$50 may be imposed.

#### Rounding

You must round off cents to the nearest whole dollar on your return. Round down to the next lower dollar all amounts that include 1 through 49 cents. Round up to the next highest dollar all amounts that include 50 through 99 cents.

However, if you need to add two or more amounts to compute the amount to enter on a line, include cents and round off **only** the total.

Example: Add two amounts (\$1.29 + \$3.21) to compute the total (\$4.50) to enter on a line. \$4.50 is rounded to \$5.00 and entered on a line.

### What if My Address Changes

If your address changes, you should notify both the Department of Revenue Services (DRS) and the Statewide Grievance Committee.

#### To change your address with DRS:

#### To change your address with the Statewide Grievance Committee:

- Call the Hartford Superior Court's Clerk Office at **860-548-2700**, ext. 3723, and ask for Form JD-GC-10 or download the form from the Connecticut Judicial Branch's web site at **www.jud.state.ct.us**
- Return Form JD-GC-10 to the Statewide Grievance Committee at the address shown on the form.
- Form JD-GC-9, *Attorney Registration*, which is sent to you annually by the Statewide Grievance Committee, also contains space to indicate your change of address.

#### **Filing an Amended Return**

If you make an error(s) on your return, you must correct the error(s) by filing an amended return using a new Form 472. Check the box indicating this is an amended return and complete it using the correct figures and information for the reporting period.

You must file an amended return claiming a refund of taxes already paid within three years of the original due date of the return and an explanation of the claim for refund must accompany the amended return.

## Who Must Sign the Return

The attorney must sign and date Form 472. If the attorney becomes legally incompetent or dies before filing the attorney occupational tax return, the attorney's guardian, conservator, executor, or administrator, as the case may be, may sign the return on the attorney's behalf.

#### **Paid Preparer Information**

Anyone you pay to prepare your return must sign and date it. Paid preparers must also enter their SSN or Preparer Tax Identification Number (PTIN), their firm's Federal Employer Identification Number, and their firm's name and address in the spaces provided.
