Dear Section 8 Voucher Holder:

Our records indicate that you were issued a Section 8 voucher for a studio or one-bedroom apartment, but have not yet returned a rental package to your Leased Housing borough office. This is to let you know that there are one-bedroom apartments available for rent at the Fabria Houses development in Manhattan using your Section 8 voucher, and that the developer of Fabria, Phipps Houses Services, Inc ("Phipps"), will be contacting you soon to discuss this exciting housing opportunity.

The Fabria Houses development consists of five new or recently-renovated buildings located at 410, 426, and 428 East 11th Street; 212-214 East 7th Street; and 617-619 East 9th Street, New York, New York. Right now, there are approximately 40 one-bedroom apartments available for rental to eligible voucher holders.

To enable you to take advantage of this opportunity, the Housing Authority will give your name, address, and telephone number (if any) to Phipps so that Phipps can contact you directly to tell you more about Fabria Houses.
