- Res 745-2003: Resolution calling upon the Augusta National Golf Club to cease its practice of gender segregation and urging all television networks and other media, particularly CBS Broadcasting, to refrain from broadcasting the Masters in 2004 and future years as long as it is held at Augusta or any other venue that promotes segregation and discrimination.
- Int 243-2002: A Local Law to amend the administrative code of the city of New York, in relation to the possession, sale and display of etching acid. (Local Law 0003-2003)
- Int 157-2002: A Local Law to amend the administrative code of the city of New York, in relation to prohibiting the operation, standing or parking of mobile billboards.
- Int 119-2002: A Local Law to amend the New York city charter, in relation to requiring that official publications of city agencies be submitted in electronic format to the department of records and information services and be made available to the public through the department's website. (Local Law 0011-2003)
- Int 96-2002: A Local Law to amend the administrative code of the city of New York, in relation to the standards of conduct of employment agencies and employers of domestic or household employees placed by employment agencies. (Local Law 0033-2003)
- Int 95-2002: A Local Law to amend the administrative code of the city of New York, in relation to the regulation of news boxes.
- Res 135-2002: Resolution supporting the rights and dignity of domestic workers.
