## **NOTES TO APPLICANT**

## 1. Passport Validity\*

A passport that has run out of pages or reached its full validity i.e.:-

- a) 10 years (for passport issued before 1 April 2005); and
- b) 5 years (for passport issued from 1 April 2005) cannot be extended.

\*Extensions to the passport validity are not allowed on the Singapore Biometric Passport. Singapore Biometric Passport holders whose passports have run out of pages or reached its full validity will have to apply for a new passport.

#### 2. The following original documents must be produced at the time of application:

- a) Passport; and
- b) NRIC.

In addition, if the passport holder is below 16 years old:

- c) Birth Certificate of passport holder; and
- d) Consenting parent's NRIC.

If the application is done through appointed representatives, the latter's original NRIC must also be produced.

## 3. Appearance during application

Singapore passport holders who are living in Singapore may submit their applications through an authorised representative by completing Part III of this application form. However, this does not exempt the passport holder from appearing in person where the Passport Officer considers it necessary to do so.

#### 4. Where to extend passport

An application for passport extension may be submitted to Immigration & Checkpoints Authority (ICA) at:

- (i) Passports Section, 2<sup>nd</sup> storey, ICA Building, 10 Kallang Road, Singapore 208718, or
- (ii) The nearest Singapore Overseas Mission.

### 5. Passport Extension for NS Liable Male Citizens

Male citizens who are between 11 and 40 years old may extend their passport at:

(i) Exit Permit Office, Central Manpower Base, CMPB Podium, Depot Road, Singapore 109676.

NS-Liable Persons under the Singapore Police Force and SCDF may also extend their passports at:

- (i) Exit Permit Office, 1 Mount Pleasant Road (Former Police Academy), Blk 2 Singapore 298333; or
- (ii) HQ SCDF, National Service Personnel Department, Civil Defence HQ Complex, 91 Ubi Avenue 4, Singapore 408827.
