

## Data Protection Statement

---

We inform you hereby that by virtue of the voluntary completion and signing of the present form you consent to the registering and processing of your personal data during the term of your membership in the Friends of KOGART pursuant to the applicable statutory provisions and the following conditions.

According to the Act LXIII of 1992 on the Protection of Personal Data and the Disclosure of Information of Public Interest (Data Protection Act), personal data shall mean any information relating to an identified or identifiable natural person and any reference drawn, whether directly or indirectly, from such information. In the course of data processing, such information shall be treated as personal data as long as the data subject remains identifiable through it.

The processing and registering of personal data is accomplished by KOGART Holding Zrt. (seat: 1054 Budapest, Szabadság tér 7. court of registration: Metropolitan Court as Company Court, company registration number: 01-10-046275, hereinafter referred to as: Processor).

The purpose of processing is to keep in contact with you as the member of the Friends of KOGART and to ensure you continuous information on the programs, news, services, allowances and other opportunities connected with the Friends of KOGART, KOGART Holding Zrt. and its affiliates. By virtue of the acceptance of the present conditions you allow KOGART Holding Zrt. to transfer your data to the affiliates or legal successors of KOGART Holding Zrt. for the purpose of providing information and creating new business connections.

The personal data processing by KOGART Holding Zrt. – beyond the above – shall not be transferred to third parties; KOGART Holding Zrt. shall make it available only in compliance with the relevant laws, and shall protect it from the access of unauthorized persons.

Upon your request KOGART Holding Zrt. shall provide information on the personal data managed by KOGART Holding Zrt. and about the procession itself, moreover you are entitled to request anytime the correction of your personal data, or – except the data processing ordered by the law – the deletion from the register. If you are not satisfied with the data processing by any reason, you may object at the processor, or may file for court action.

Any other question in connection with data processing and data protection not regulated herein shall be governed by the Data Protection Act, the Act CXIX of 1995 on the Use of Name and Address Information Serving the Purposes of Research and Direct Marketing, the Act XLVIII of 2008 on the Basic Requirements and Certain Restrictions of Commercial Advertising Activities and the Act CVIII of 2001 on Electronic Commerce and on Information Society Services.
