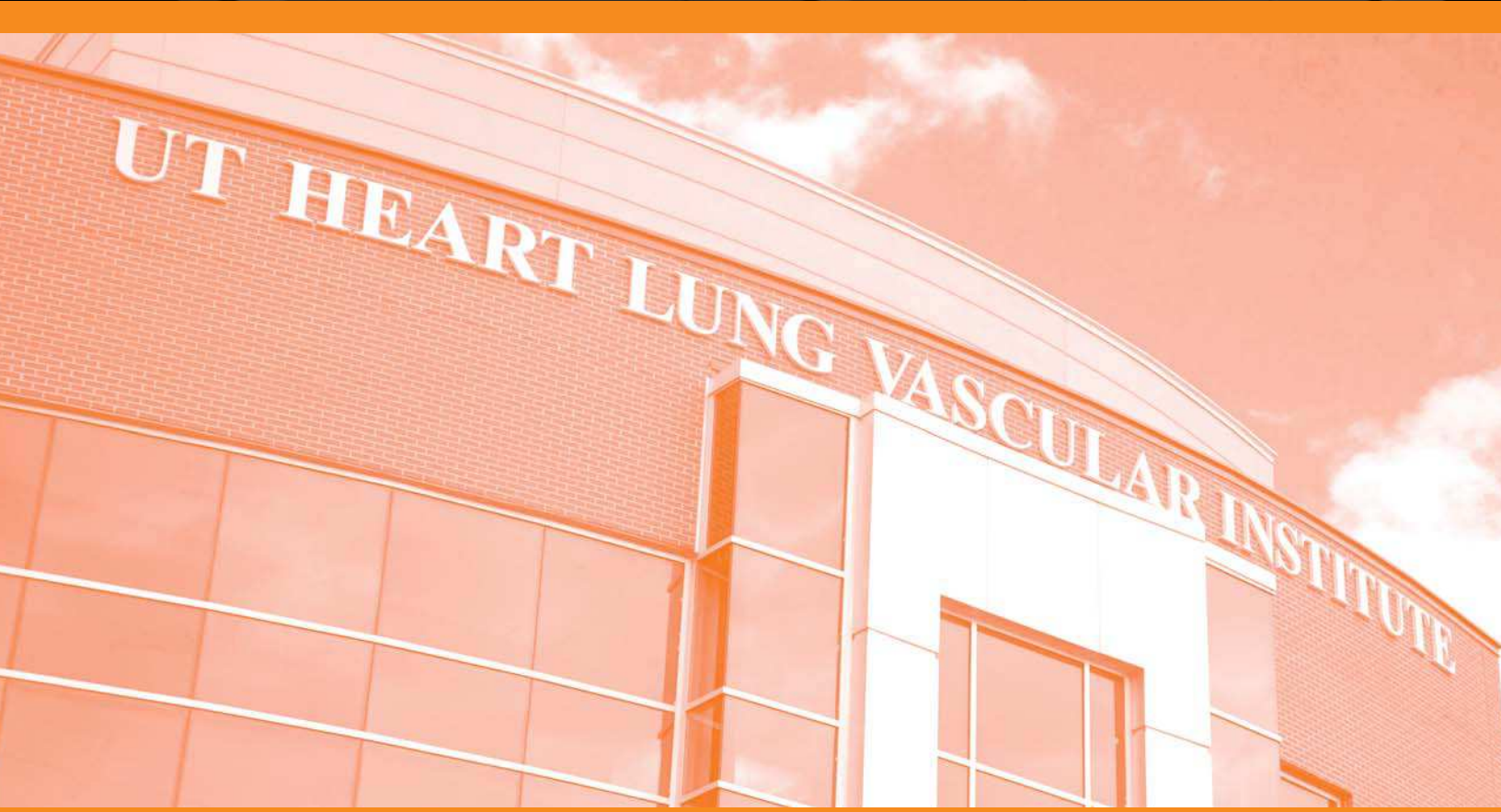

A major road construction project will be underway at this time, closing I-40 through Knoxville. Here are the best alternate routes to help you reach the hospital:

I-40 West to I-640 West to I-275 South to I-40 West to Alcoa Hwy 129 South (exit 386B) to UTMC. 13.4 Miles from I-640

I-40 West to Hall of Fame Drive (exit 389) turning right onto to Summit Hill and turning left onto S. Central Street to Neyland Drive turning right onto Kingston Pike to Hwy 129 South to the Medical Center. 9.8 Miles and 15 Traffic Lights from the I-40 and I-640 split

Driving directions traveling on I-40 East:

Take the 129 (Alcoa Hwy) exit (386B). Travel south on 129 approximately one mile to the UT Medical Center/Cherokee Trail exit. Follow the exit onto the Medical Center campus
