- File the Free Application for Federal Student Aid (FAFSA) with the U.S. Department of Education
- Complete all sections of this pre-application and return it to the Office of Student Financial Aid
- Sign the electronic Parent PLUS Master Promissory Note (eMPN) at the U.S. Department of Education's website at <http://dlenote.ed.gov>. You must have your U.S. Department of Education Personal Identification Number (PIN) to sign the Parent PLUS eMPN. This is the same PIN that you use to sign your student's FAFSA. The signature process is complete once you can view the screen that indicates success!
