

LIPSCOMB Employment Discounts for Undergraduate Students

Lipscomb University offers tuition discounts to students whose parent/spouses are employed <u>full-time</u> in certain Christian works that are associated with the churches of Christ. The discount is available from the beginning of employment and must be verified each year. Employment eligibility for a discount includes:

1. Administrator, teacher or staff of a current National Christian School Association member school. Though a day-care facility is not a school by our definition, licensed teachers who teach kindergarten are eligible. Other day-care facility employees are not eligible.

Children of CEO and/or President	50% tuition discount
Children of Principal and/or Headmaster	25% tuition discount
Children/Spouses of Teacher and/or Staff	25% tuition discount

2. Administrator, teacher or staff of a current National Christian School Association university.

Children of Christian University Faculty and/or Staff50% tuition discount

3. Youth minister with ten years full-time employment, and still in the field, or 20 years employment, whether or not still in the field. (Must document service.)

Children of Youth Minister50% tuition discount

4. Missionary in Foreign Country (still in the field)

Children of Foreign Missionary50% tuition discount

These tuition discounts are available to children who are enrolled in <u>undergraduate studies</u>, who are <u>less than 25 years</u> old, and who are dependent for federal income tax purposes. Married children are not eligible. *This discount is subject to GPA and probation restrictions as described in the current <u>Undergraduate Catalog</u> and is available only for the customary duration of an academic program.

Please complete the Parent Section of the Employment Verification Form found on the reverse side of this paper. A school official should complete the Employer Section for those persons seeking a tuition discount through Christian School or Christian University employment. A church Elder from a sponsoring congregation should complete the Employer Section for persons seeking a tuition discount as a full-time youth minister or foreign missionary.

*The tuition grant, in conjunction with academic scholarships, cannot exceed 50% of tuition. However, a student may choose the tuition grant or academic award, whichever is greater. A full load of 12 hours is required to receive the grant.
