Loyola's Department of Campus Safety provides many services to the Loyola community with an emphasis on a safe and secure environment. At the Lake Shore Campus, Safety Officers patrol the area 24 hours a day, seven days a week. Water Tower Officers patrol the downtown campus 24 hours a day, seven days a week. Any suspicious activity or potentially dangerous situations should be reported to Campus Safety immediately. Emergency phones are located throughout each campus. The security dispatcher may be reached by simply dialing the extension 4-4911 on an on-campus telephone or by pressing the red button on a designated emergency telephone, which connects you directly to Campus Safety. From off-campus locations you can reach Campus Safety by dialing 773-508-6039.

President's Safety Message

Perhaps we wonder, from time to time, whether we are in a safe place: on the street, on public transportation, or maybe even in our homes. Personal safety often isn't much about where we are as it is about how we are-our awareness and interpretation of our surroundings. It's possible to learn ways to enhance one's own safety. Whether you're new to Chicago or you're a life-long city dweller, we want your time here at Loyola and in this city to be enriching and safe. Loyola is committed to the safety and security of students, faculty, staff, administrators, alumni and visitors. Thus, we encourage everyone to be alert and active for their own safety, and we provide tools to help: crime prevention and safety seminars, regular tours of hot spots near campus, classes on self-defense techniques, and partnerships with student, faculty and staff groups.

We have comprehensive campus and neighborhood security plans to assist you when you do need help. Our officers are available on foot patrol, on bikes, and in security vehicles, and our campuses are equipped with visible security phones. Residences have desk monitors and secure entrances, and Loyola Security personnel readily and regularly escort students to campus and nearby apartment residences during evening and early morning hours. We use the university's e-mail system to send safety alerts, including tips for safe behavior; and we post similar flyers on campus. Our security department also operates a free daily shuttle bus service that links to both our Lakeside Campuses and their diverse neighborhoods. Busses run from early morning

through the evening.

Loyola has worked diligently over the years to be a good citizen in our Lake Shore and Water Tower neighborhoods. We feel responsible for their maintenance and growth. In turn, the city of Chicago offers us all its resources: museums, theaters, sporting events, historic neighborhoods and parks, and internship and volunteer opportunities at many institutions. However, being a city resident requires being aware that not every one is a good neighbor, and that urban life has its share on anti-social and illegal activity. To help stay safe, wherever you are, take advantage of our security department's classes to add safety skills to your life skills. Be enriched in all aspects of urban living during your time at Loyola University Chicago.

CRIME PREVENTION SERVICES AND PROGRAMS

Campus crime is an issue of mounting concern for colleges and universities across the country. Loyola University Chicago's Lakeside Campuses have developed an environment where safety concerns are aggressively and proactively addressed. In recent years, the University has launched a number of initiatives to bolster its safety program.

· Various safety presentations on Self Defense and "Streets Smarts" are conducted free of charge to all members of the Loyola community.

·Our officers regularly patrol the Lakeside Campuses by car, golf cart, bicycle and foot.

•One button emergency phones are located inside and outside campus buildings and throughout the campus grounds.

·Security reviews are conducted by university staff. They include surveys of the campus lighting and

safety checks of the emergency phones, security screens and windows, door lock mechanisms and

key card systems.

 \cdot There is a Van Escort Service that runs free of charge.

 \cdot A limited shuttle bus service is available for direct travel between the Lake Shore and Water Tower Campuses.

 \cdot Safety bulletin boards located in high traffic areas include the latest crime statistics and maps with colored symbols signifying where and what type of incidents have occurred.

Personal Safety Seminars

Our Student Liaison Officer will provide Safety Seminars upon request. These short seminars can be tailored to meet your group or individual needs, with a focus in such areas as personal safety, travel safety, parking and driving safety, sexual assault prevention, street smarts, theft prevention and more.

Women's Self-Defense

The Rape Aggression Defense Systems is a program of realistic, self-defense tactics and techniques. The RAD System is a comprehensive course for women that begins with awareness, prevention, risk reduction and avoidance, while progressing on to the basics of hands-on defense training. Our courses are taught by certified RAD instructors who will provide you with a workbook/reference manual. Hot Spots Tours

Taking a Hot Spots Tour is a great way to see the neighborhoods surrounding Loyola. Our tours show you popular places to shop, eat, conduct business or just socialize. We show you what's hot and what's not. The tour is guided by a Crime

Campus Safety Officers

The Department of Campus Safety is comprised of three categories of officers;

Campus Security Officers have completed a formal 20 hour security officer training program which is recognized by the State of Illinois.

Campus Safety Officers are graduates of a recognized state-certified police training academy. They have successfully completed at least 400 hours of police academy training, and have passed the written Illinois Law Enforcement Examination. These officers are not armed.

Campus Police Officers are sworn, armed police officers who are certified through the State of Illinois.

In addition, some of our officers have specialized supplementary training. The officers in our bike patrol unit have completed the International Police Mountain Bike Association training course in bicycle patrol techniques. Some of our officers are certified instructors in the Rape Aggression Defense program for women's self defense techniques. Finally, many of our officers have college degrees or are pursuing a degree during their off-duty time.

Community Policing

The department of Campus Safety is committed to the safety and well-being of its community. To help us fulfill our mission statement we have expanded our crime preventing services to include Community Oriented Policing (C.O.P.). C.O.P. consists of three principal components: community partnership, problem solving and change management. Community policing seeks to build a strong relationship between the police, local government, and the community it serves. Through a collaborative effort, criminal activity and quality of life issues are identified by examining the characteristics or problems and applying appropriate problem-solving remedies.

Building access: after hours, weekends and holidays

Campus Safety Officers will admit an individual or a group into a building or room after hours, on weekends and holidays only after receiving written authorization from the appropriate department prior to the date the facilities are to be used. Authorization should be written for an individual or group by the person in charge of the room or area involved. The request should be signed by a dean, director, department head or his/her appointed authorized person. Authorized persons must not allow unauthorized individuals to enter. I.D. is required for access to university buildings.

Lost and Found

Lost and found items may be given to a Campus Safety officer at any time or may be brought to the Campus Safety Department, 24 hours a day, 7 days a week. Property will be held for 60 days before it is disposed of.

Bicycles

Secure your bike to designated bike racks only. Do not lock your bike to benches, railings, sign posts, etc.

Bikes that are locked in unauthorized areas may have their locks cut and be removed. Use the bike corral on the first floor of the main parking structure by filling out the online registration form at <u>www.luc.edu/depts/safety</u> Your I.D. card will then be activated for access to that area.

SAFE AND SOUND ADVICE

Residence Hall Tips

- ·Always keep your dorm room doors locked, even when you are inside.
- ·Keep an inventory of valuable possessions and record serial numbers.
- •Don't loan your keys to anyone.
- ·Don't mark your key chain with your name or address. Lost keys can lead to theft.
- ·Don't let unfamiliar people into your room.
- ·Don't prop open residence hall doors that are locked.
- Call Campus Safety at 44-911 if you see strangers loitering in or around the dorms.

Street Tips

- ·Walk or jog with a friend whenever possible.
- · Stay alert and tuned-in to your surroundings.
- ·Walk or jog in well-lighted areas, stay away from alleys.
- •Tell someone where you are going and when you will return.

 \cdot Carry a whistle or a body alarm. This can serve as a reminder to exercise caution, and can alert someone in the area that you need help.

·Use the Campus Escort Service -call 8-RIDE.

Theft Prevention

 \cdot Don't leave personal property (purses, backpacks, calculators, etc.) unattended in classrooms, study area or libraries.

·Lock your bike to a bike rack with a late model kryptonite lock. (Older models can be picked.)

·Theft is our biggest crime problem. Report all thefts to the Department of Campus Safety

(773-508-6039) immediately.

Secure your bike to designated bike racks only. Do not lock your bike to benches, railings, signs, etc.

Use the bike corral on the first floor of the main parking structure by filling out the online registration form at <u>www.luc.edu/depts/safety</u> Your I.D. card will then be activated for access to that area.

Obscene Phone Calls

 \cdot Hang up as soon as you realize the nature of the call. Don't try to find out who the caller is, and don't show any reaction.

•Note the time, what the caller said, a description of the voice, and any background noises.

·Advise your resident assistant and hall director, and make a report with the Department of Campus Safety.

Emergency Call Boxes

There are numerous emergency phones located inside and outside campus buildings on both Lakeside campuses. In an emergency, simply push the "ON" button to notify the dispatcher of your location and your need for assistance. It is best to stay on the line, when possible.

REPORTING EMERGENCIES

For any life-threatening emergency first call 911, then immediately call Campus Safety at 44-911 or 773-508-6039:

- 1. Give your name and phone number.
- 2. Describe the nature of the emergency.

3. Be prepared to respond to the dispatcher's instructions.

In response to your call, the dispatcher will send an officer and appropriate police, fire, or ambulance units to your location immediately.

Sexual Assault

Loyola University does not tolerate any form of coercive sexual behavior including sexual assault against any of its students. Sexual assault as defined in the **Student Handbook at** <u>http://www.luc.edu/depts/studaff/handbook/</u> is any actual or attempted non-consensual sexual activity that injures or threatens to injure another person including but not limited to rape, attempted intercourse, sexual touching, exhibitionism or sexual language of a threatening nature. All complaints are taken seriously and no one reporting sexual assault, including third parties, will suffer retaliation or reprisal from the university. Complaints of sexual assault will be treated in confidence to the extent feasible, given the need to conduct a thorough investigation and to take corrective action. It is important to preserve evidence, as it may be necessary for proof of criminal sexual assault. If it is determined through an appropriate and prompt investigation that sexual assault has occurred, effective corrective action will be taken to attempt to ensure that it does not recur. Depending on circumstances and the severity of the conduct, corrective action could range from an oral/written warning to dismissal or expulsion. Programs to promote awareness

The University Wellness Center, upon request, offers educational programs to promote awareness of sexual assault including "How to Help a Survivor of Sexual Assault" and How to Reduce Your Risk for Sexual Assault". The Department of Campus Safety offers a "Sexual Assault Prevention" course which is designed to provide strategies to help one avoid

becoming a victim, as well as information about what to do when confronted by an attacker. The Department also offers a self-defense course for women entitled "Rape Aggression Defense Systems."

Responding to Sexual Assault

Loyola University encourages the reporting of all incidents of sexual assault. The privacy of the victim will be respected at all times. It is the victim's decision whether to press a complaint or to continue with any form of resolution. It is the right of the victim not to report, but if she/he does report, no action will be taken without the victim's consent. A student who has been a victim of a sexual assault is encouraged to report the incident to the Dean of Students Office. A staff member will advise the student of her/his rights and the appropriate procedures for filing a complaint. Information will be given to the student regarding the reporting of the incident to Public Safety and the Chicago Police.

Sex Offender Information:

The Victims of Trafficking and Violence Protection Act of 2000 requires colleges and universities to inform students and employees how to learn the identify of registered sex offenders living on or near campus. This policy was updated to comply with the Campus Sex Crimes Prevention Act, which took effect October 23, 2002.

Sex offender information is compiled by the Illinois State Police. The Illinois State Police maintains a website that allows you to search their sex offender database online at <u>http://www.isp.state.il.us/sor/</u>. To learn the identity of registered sex offenders on or near campus, or anywhere in Illinois, visit the Sex Offender Database. Once there, you can search by city, county, or zip code.

Alcohol

Students and guests are subject to Illinois state law, which prohibits the sale, possession, consumption or provision of alcoholic beverages to or by any person under the age of 21. Possession and consumption of alcoholic beverages on campus by individuals 21 years of age or older is prohibited in any public area (any area except the private room of students living in the residence halls or university apartments) on campus, unless approved by the Dean of Students. Students must properly dispose of all alcohol present when asked by a university official.

In Residence Halls

In rooms or apartments where all residents are under the age of 21:

·Containers that contain or previously contained alcohol are prohibited.

• Students under the age of 21 may not be in the presence of alcohol.

In rooms or apartments where at least one roommate is 21 or older:

 \cdot Alcoholic beverages may only be consumed by residents and their guests who are 21 years of age or older, in the privacy of their room or apartment with the door closed and in an atmosphere which does not foster excessive consumption or create significant noise or other disturbances.

· Alcohol may not be consumed in the presence of minors, with the exception of an underage roommate. Under this circumstance, no guests (regardless of age) may consume alcohol in the room as long as the underage roommate is present.

 \cdot Students under the age of 21 may not be in the presence of alcohol, with the exception of underage roommates (see above).

·Collections of containers that contain or previously contained alcohol are prohibited.

·Alcohol in excess as determined by members of the Department of Residence Life staff is prohibited. This includes but is not limited to kegs of beer.

At student sponsored events

The sale of alcohol to any individual, regardless of age, is strictly prohibited.

The university's food service provider must be the sole distributor of alcoholic beverages at any university event. Only authorized staff members from the university's food service provider may serve alcohol, when alcohol service is approved at any event. Hosts and/or guests may not bring any alcoholic beverages into an event where alcohol is provided.

The university does not have a license to sell alcoholic beverages. Consequently, neither the university nor the student organization may sell alcohol, accept donations in lieu of payment for alcoholic beverages, or charge admission to events at which alcohol will be served. Alcoholic beverages must be served at no cost to the guest.

• The university's food service provider may provide host bars only. Host bars are paid entirely by the host of the event and have to be billed by the whole containers of alcohol consumed. Cash bars, those where guests pay by the drink, are not permitted.

In compliance with state and municipal laws, only persons 21 years of age or older may consume or possess alcoholic beverages.

The university's food service provider is responsible to check identification of individuals to ensure that alcohol is not served to persons less than 21 years of age.

·Alcohol may not be the main focus of the event.

· Non-alcoholic beverages and food must be available at all events where alcoholic beverages are served. Non-alcoholic beverages and food should be featured as prominently as alcoholic beverages.

• There must be established time limits for the serving of alcohol at any event. Hours of service must be shorter than the duration of the event.

·Alcohol should not be served to persons who appear to be intoxicated.

· Groups eligible to apply to host events at which alcoholic beverages will be served are limited to registered student organizations whose membership is restricted to graduate or professional students. Undergraduate student organizations may **not** sponsor events where alcohol is present.

• Registered student organizations may apply to have alcoholic beverages served at events where persons under 21 years of age are in attendance. At these events, several representatives from the sponsoring department or administrative unit must be present and monitor the event.

• At events where persons under 21 years of age are present, alcohol service areas must be separated clearly and completely from any non-alcoholic beverage areas. Sufficient space shall be designated for the alcohol area to avoid congestion and related disruption.

Admission to the event is restricted to the Loyola University Chicago community and their invited guests.

An Event Planning Form should be used to request approval for the service of alcohol. These forms must be submitted a minimum of fifteen (15) business days prior to the proposed event (see "Special events").

The Dean of Students will have discretion in approving the service of alcoholic beverages at the event based on the age of the guests, size, time, location and management of the event.

Department of Public Safety personnel may be required due to the size, type and hours of the event at the expense of the sponsoring organization (see "Special events").

• The Dean of Students may terminate the service of alcohol or the event, as the Dean of Students deems necessary.

·Fees may be assessed to the sponsoring group for additional maintenance or damages incurred.

· Alcohol should not be served at events held during the workday unless approved by the President.

The Rome Center has a Student Handbook which provides information on conduct policies and safety issues governing students attending the Rome Center. All students must attend an orientation program before attending classes at the Rome Center. For more information see:

Drug and Alcohol Abuse Prevention

Lovola University Chicago is committed to the adoption and implementation of a program to prevent the unlawful possession, use or distribution of illicit drugs and alcohol by students. In support of this commitment and in compliance with the Drug Free Schools and Communities Act of 1989, the following information is provided through the Student Handbook at: <u>http://www.luc.edu/depts/studaff/handbook/</u> All members of the Loyola community are expected to comply with this policy.

Loyola University Chicago's Emergency Response Plan (ERP)

The lakeside campuses are a complex system of buildings, functional units, schools, departments, and services located in two uniquely different areas of Chicago. The Emergency Response Plan (ERP) provides a framework by which the university can effectively and efficiently respond to and manage major emergencies and disasters that may affect our campuses. The ERP is the basic guide for responding to any emergency situation on university-owned property that could cause death, serious injury, disrupt operations, or cause physical or environmental damage. This plan strives to put Loyola in a proactive position to protect students, staff and faculty, as well as the community and our environment, in case of a major emergency or disaster. It facilitates compliance with certain regulatory requirements of federal, state and local agencies, and enhances the university's ability to quickly return to normal operations following an emergency or disaster.

The ERP will not, nor can it be expected to, address every possible emergency situation that could face the lakeside campuses. Therefore, each unit of the university must become familiar with this plan, particularly the notification process, to ensure an adequate response to any and all possible emergencies. In addition, each unit should consider extending parts of this plan to include more specific details as they relate to various departmental needs. Missing Students

Loyola University Chicago is very concerned about students who are reported missing. Any missing student report that is brought to the attention of Campus Safety will be immediately investigated thoroughly by LUC Campus Safety. Any student reported missing will also be referred to the Chicago Police Department for additional investigations and resources.

Every on-campus student has the ability to register a confidential contact person who will be notified if they are reported missing. This can be done by using LOCUS, the online portal. Only authorized persons and law enforcement will have access to this information.

The parents or guardians of any student under the age of 18 (and not emancipated) will be contacted if the student is reported missing.

If a student has been missing for more than 24 hours you should immediately report it to Campus Safety by calling 773-508-6039. This number is open 24 hours a day, 7 days a week, 365 days a year. Reports of a missing person can also be referred to Student Development at 773-508-8840 during normal business hours.

These procedures can be implemented at any point if circumstances warrant a faster response.

The Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act is the landmark federal law, originally known as the Campus Security Act that requires colleges and universities across the United States to disclose certain security policies and crime statistics on and around the campus.
