Dear SSU Faculty and Staff:

As summer draws to a close, students will soon converge on the Savannah State University campus to start a new academic year. And what an exciting year this promises to be:

- Another record-breaking fall enrollment is projected,

Consequently, increasing private funding for SSU is imperative to ensure fulfillment of our mission.
