In this process we will compare information from your FAFSA with your 2011 federal IRS tax return transcript (along with your spouse's if you are married, or parents' if you are considered dependent for federal aid purposes). If there are differences between your FAFSA and the documents provided, Simpson College will make the necessary corrections. Your financial assistance may be delayed due to missing or incomplete information. Your verification process must be completed within 30 days of your last day of attendance in order to receive financial assistance.

- 1. Collect your (and your spouse's or parents') financial documents (IRS tax transcripts, W-2.).
- 2. Call the office of financial assistance if you have questions about completing this worksheet (800-362-2454 x1664 or 961-1664).
