- ✓ Official scholarship award letter
- If you will use your own **personal funds**, you must provide a bank statement dated **within the last 6 months** or complete the Bank Certification.
- If you will be supported by a **private sponsor** (family member, friend, or private institution), the sponsor must sign the Sponsor Information and provide proof of finances by submitting a bank statement or completing the Bank Certification.
- If you will be sponsored by a **public agency** (embassy, home government, public institution, religious organization), the agency must provide written verification of the term and amount covered.
