PROGRAM DESCRIPTION

This is the first generation of young people our country has ever seen being raised stigma free from gambling. Today's youth are surrounded by gambling messages and opportunities. How do we keep them safe from developing gambling problems? This program is for parents, teachers, and preventionists, counselors, and administrators interested in the impact of gambling on today's youth. Often underestimated, the impact of gambling as hidden addiction includes a summary of youth prevalence studies, findings of recent research and a summary of awareness and prevention programs for use in local communities and statewide.

PROGRAM OBJECTIVES

During this program, participants will be able to...

- Learn about prevalence rates for youth gambling including common definitions for youth gambling disorders.
- List the warning signs for gambling problems.
- Identify five ways society promotes gambling to vulnerable minors.
- List the five required elements of effective problem gambling prevention efforts.
- Note three key differences in substance abuse prevention and gambling prevention initiatives.
- Review proposed plan for pilot problem gambling prevention initiative.

- Increase knowledge of prevalence of youth gambling
- Increase knowledge of warning signs of youth gambling
- Increase knowledge of societal context of increased popularity of gambling among youth

Joanna Franklin completed her Bachelor's and Master's degrees from Johns Hopkins University. She is currently the Director of Training and Network Development for Trimeridian Inc., a consulting firm specializing in design, implementation, and installation of gambling treatment programs. Ms. Franklin has worked with several state governments, the casino industry, the racing industry, state lotteries, the FBI, CIA, and Pentagon. She has designed and presented clinical programs in over 43 states, for over 30 tribal nations, 10 Canadian provinces, and nine other nations on five continents. She has published two book chapters on: "Family Treatment," and "Adolescents and Problem Gambling" with the Harvard School of Addiction Studies. Ms. Franklin is currently: Co-chair of the National Gambling Counselor Certification Board; President of the Institute for Problem Gambling; President of the Maryland Council on Problem Gambling and on the Board of Directors of the National Council on Problem Gambling. She is the winner of the Council on Compulsive Gambling of New Jersey "Person of the Year" Award, The National Council on Problem Gambling Goldman Award for a lifetime of dedicated service, and the NCPG first "Distinguished Service" Award for volunteer services.

CAROL ROBERTSON

Carl Robertson is the training specialist and CAP facilitator for the Council on Problem Gambling of Pennsylvania and the Director of Network Development and Training for the Maryland Council on Problem Gambling. Carol is bilingual (English/Spanish) and has Master's degrees from Mt. St. Alphonsus in both Religious Education and Theology. He has a Bachelor's degree in Philosophy and is certified as a Senior Professional in Human Resources (SPHR) and as a DiSC trainer. With over 15 years experience in the Training and Development Field, Mr. Robertson has held Senior Management positions in both the profit and not-for-profit environments. Additionally, he has served as Employee Assistance Program coordinator and has been an adjunct faculty member of Penn State University's York campus.
