

## Undergraduate Petition for Academic Forgiveness

Academic Forgiveness is a status that enables students to return to the university with a reset cumulative grade point average (GPA). You may only apply for academic forgiveness after a minimum of 8 consecutive semesters (fall/spring) from the time of your last enrollment. Academic Forgiveness can be applied ONLY at the time you return to the University, prior to the end of the second week of the term in which you return.

This petition should be submitted as soon as possible once re-enrolled/re-instated.

- The Cumulative GPA will be reset to 0.00.
- Once posted, neither the reset Cumulative GPA nor courses included/excluded can be reversed or revised.
- All prior courses and grades will remain on my academic record and transcript.
- The notation of “Academic Forgiveness” will be recorded on my transcript.
- Courses previously earned at Temple University with grades of D+, D, D-, F and NC will not be used for credit. Credit will be considered for courses with grades of A, A-, B+, B, B-, C+, C, C- and CR. The department to which I am returning has final approval of credits that will count towards graduation. Schools/Colleges may disallow credits towards graduation for some older courses.
- Please note that Academic Forgiveness may impact your eligibility for student financial aid. It is strongly recommended that you meet with Student Financial Services prior to agreeing to enact Academic Forgiveness (as it cannot be undone).
- In electing the forgiveness option, I may request approval from my school to repeat a course one additional time if I previously exhausted my repeat options for that course under the policy on Repeating a Course ([http://policies.temple.edu/getdoc.asp?policy\\_no=02.10.12](http://policies.temple.edu/getdoc.asp?policy_no=02.10.12)).
- Students are afforded one opportunity for Academic Forgiveness (please see full policy at [http://policies.temple.edu/getdoc.asp?policy\\_no=02.10.17](http://policies.temple.edu/getdoc.asp?policy_no=02.10.17)).
- Eligibility for Graduation (Latin) honors is calculated on credits earned after Academic Forgiveness. Please refer to the Latin Honor policy to review residency requirements to receive these honors. Credits prior to Academic Forgiveness do not count toward the Latin honors residency requirement.
