Testing Overview

This document addresses the test runs and cases constructed to verify the correct installation of Release 1748. The test is made up of the following steps:

1. Control Data Base (CTL) Initial Load (LOADCTL)
2. Employee Data Base (EDB) Initial Load (LOADEDDB)
3. Execute EDB Online File Maintenance (ON-LINE)
4. Execute EDB Batch File Maintenance (EDBMAINT)

CONTROL TABLE (CTL) INITIAL LOAD (LOADCTL)

Description

This job loads the DB2 CTL database.

Verification

Ensure that the DB2 CTL has been successfully restored by verifying normal completion of the job and ensuring that all tables have been successfully loaded into the data base. The data in the members in PDS UDB2CTL already reflect the updates applied to the DB2 Control tables.

EMPLOYEE DATA BASE (EDB) INITIAL LOAD (LOADEDDB)

Description

This job loads the EDB database.

Verification

In order to assure successful completion of this job, verify that the EDB has been successfully restored by verifying normal completion of the job and ensuring that all tables have been successfully loaded into the data base.

EDB Online File Maintenance

Description

In order to verify that program PPEC110 has been installed correctly, the Citizenship Status Code (EDB0109) needs to be changed to "F" or "X".

- Log on to the test CICS region.
- Go to the EALN Screen.
- Perform the following tests:

Test #1

- Change the Citizenship field from **N** to **F** for employee **777000008**.
- Enter **19** at the Tax Treaty Income Code field.
- Enter **Y** at the Non-Resident Alien Tax Form Indicator field.
