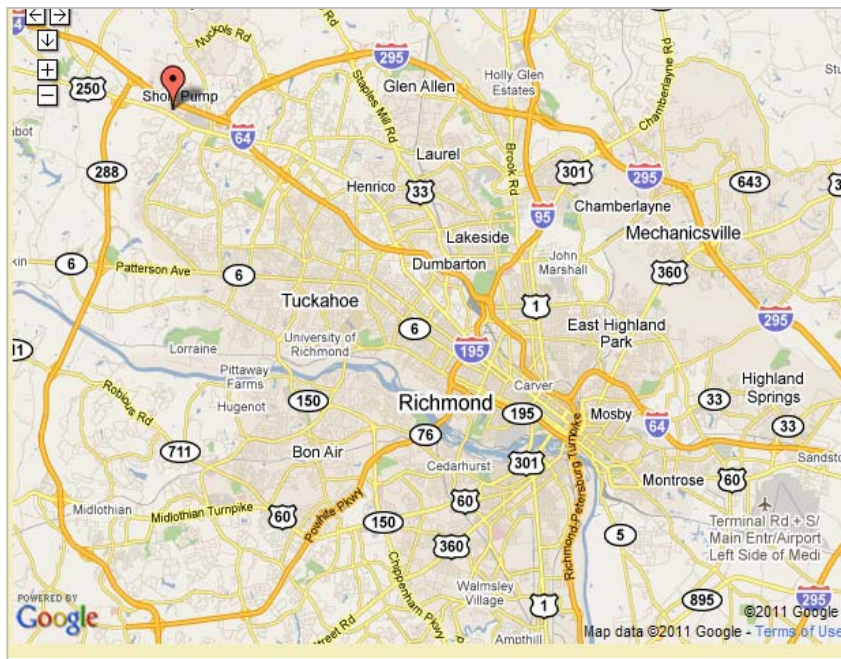
Hotel Information
