## Who Should Attend?

Participants should have some professional knowledge of the range and scope of school based services and the SLP's role. This program is also appropriate for graduate students who are currently enrolled in a speech-language pathology program.

## **Program Summary**

The roles and responsibilities of the SLP working in the educational setting have changed greatly over the last several decades. The roles will continue to evolve as our understanding of the needs of children with communication disabilities expands, as the impact of communication impairments on learning performance is more clearly defined, and as methods for delivering services improve. School-based SLPs still function as specialists. However, we can no longer implement our programs in isolation from the rest of the education system. SLP services must be an integral part of the total educational program for children with disabilities. We must focus our efforts on "Matching the Right Student to the Right Interventions, the Right Services, and the Right Providers".

This practical course brings a fresh approach to school-based speech-language service delivery. Ten critical steps are defined and discussed. Participants look at each step from the perspective of their own role, organization, population, services, and goals. Participants take away tools, strategies, and an action plan for reframing and improving their own programs.

## Learner Outcomes

After completing this session, participants will be able to:

- 1. Define characteristics of an effective, school-based, speech-language service delivery program.
- 2. Discuss new SLP roles and responsibilities with school administrators, educators, families, and students.
- 3. Establish a variety of communication strategies and venues for educating others about the SLP program.
- 4. Create meaningful relationships with teachers and collaborate to plan and deliver effective services
- 5. Administer 5 tools for evaluating student's classroom performance, determining impact of teacher's instructional communication and recommending key modification strategies.
- 6. Engage family members in planning and intervention.
- 7. Use technology in treatment and documentation.
- 8. Implement processes for tracking and reporting outcomes.
