## Conditions for lifting a voluntary gambling suspension

- The suspension is for an undetermined duration. It can be lifted at the earliest after 12 months, upon written request to the casino concerned.
- The application to lift suspension must be submitted to the casino originally responsible for its implementation. If the casino in question is no longer operating (Biel, Thun, Gstaad, Saxon, Rheinfelden, Weggis), the application can be submitted to any other casino.
- The written application to lift the suspension must be accompanied by the following documentation:
  - valid official proof of identity (Passport, ID Card, Swiss Residence Permit, Swiss Driving Licence)
  - extract from the Federal Debt Collection Register (dating back no longer than 3 months); no debt collection claims shall be pending.
  - proof of current income based on salary certificates for the past 3 months
  - bank account statements for the past 3 months
  - in the event of no own income (for example, housewife) a written agreement from your financer
  - proof of financial status, based on written evidence that adequate resources are available for gambling.

## **Procedure**

- After submission of the written application for a lifting of voluntary suspension, the Grand Casino Bern will acknowledge receipt in writing and also advise on the further procedure.
- You will be invited to a discussion on our premises; please ask at the reception desk of the Grand Casino Bern (not the Hotel Allegro).
- The discussion will be conducted by a representative of the Grand Casino Bern specializing in social concept matters, and also by a representative of the "Berner Gesundheit" counselling office.
- The guest will then be required to sign a statement confirming that he/she has been correctly informed of the procedure to lift suspension, that he/she has submitted the required documents and that the statements he/she has made are complete and in accordance with the facts.
- The discussion will clarify whether adequate financial resources are available for future gambling; and whether the reasons which led to the voluntary suspension no longer exist.
- Following the discussion and examination of the submitted documents, the management of the Grand Casino Bern will decide whether or not the voluntary suspension should be lifted.
- The guest will be informed in writing of the management's decision and the reasons for it.
