### I. NEWS FROM MENTAL HEALTH EUROPE

#### WHO Ministerial Conference on Mental Health

The conference was organised in Helsinki, 12-15 January 2005, by the Regional Office of the World Health Organisation and was hosted by the Finnish Ministry of Social Affairs and Health. The European Commission and the Council of Europe were key partners in this event.

MHE President Claude Deutsch, MHE Director Mary van Dievel and Policy advisor John Henderson represented Mental Health Europe at the conference.

Board members Pirkko Lahti, Brian Howard and Petr Nawka, as well as other 13 representatives of MHE member organisations attended the conference.

Claude Deutsch highlighted that Mental Health Europe has been fighting for years for the rights of people with mental health problems, as well as for their inclusion in society. He welcomed the WHO Declaration and Action Plan and said that MHE would do its best to make them known.

Approximately 500 people attended the conference, from which 31 Ministers of Health. Representatives of people with mental health problems and their families and carers had the opportunity to express their concerns about their involvement in mental health policy-making, and to talk about stigma, taboos and discrimination they are facing in everyday life.

John Henderson talked about "Reforming Policy and Services in Europe".

### Seminar on European Policies

MHE will organise a seminar entitled "European policies towards the integration of people with mental health problems", which will be held in Brussels on Friday 4 February 2005. # Finnish Association for Mental Health-Conference for NGOs

The Finnish Association for Mental Health co-organised a Conference for NGOs on 11 January, a day before the WHO Ministerial Conference on Mental Health. This was the NGOs Pre-conference of the official WHO Ministerial Conference.

The scope and purpose was to raise to discussion issues that the organizing NGOS consider significant for mental health policy making, especially in promotion and prevention, and social innovations.

The meeting also aimed at compiling the NGOs recommendations for the WHO Ministerial Conference on mental Health. A Declaration was adopted and

presented as the message of European NGOs for the Health Ministers present at the Conference.

The Declaration highlighted the need for enhancement of social inclusion, equality between people and the minimization of all non-voluntary treatment and stressed that more economic and social resources have to be allocated toward empowerment, political participation and service provision by user, family and other civil society organizations..

### Advocacy France - concern for the tragedy in Pau

After the murder of two nurses at the psychiatric hospital in Pau, southwest France, Advocacy France expressed solidarity with the families and colleagues of the victims and urged for a coherent mental health policy and adequate support for mental health care staff to practice their profession.

Advocacy France expressed also concern that this dramatic event, exploiting the feeling of fear, might lead to increasing discrimination and social exclusion of people with mental health problems.

The National Federation of Associations of Patients and ex patients in Psychiatry, together with the National Union of Families and Friends of mentally III People made also a public statement highlighting the high level of bed occupancy in psychiatric wards and the need for an appropriate mental health plan.

The European Commission organised in Sofia (Bulgaria), from 9 to 11 December, an European Conference on the issue of equal opportunities for people with disabilities.

MHE was invited, together with a limited number of participants from the candidate countries (Bulgaria, Romania, Turkey, Croatia) to share experiences to promote the exchange of good practices and to provide information on the approaches taken at EU level across a wide number of policies.

The conference was opened by Mrs. Mrs Christina Christova, the Bulgarian Minister for Labour and Social Policy and Mrs. Odile Quintin, the Commission Director-General for Employment, Social Affairs and Equal Opportunities.

The key themes were:

- Right-based approach to disability,
- Promoting action and dialogue for a stronger civil-society,
- Creating the conditions for equality of opportunities.

Each of the themes were introduced by eminent speakers and lively discussions proved participants' enormous interest and expectations.

It is important to stress that on several occasions, the specific needs of people with mental health problems were mentioned.

Removing the psychological barriers and changing the attitudes were challenging issues for all the countries, together with providing with providing specific and separate support care for people with mental health problems and people with learning disabilities.

An important theme of the event was the need for action through dialogue and a stronger civil society. *For further information:*

The conference "Ratifying the Constitutional Treaty and Developing Participatory Democracy" is organized by the Social Platform, in the framework of the Act4europe Campain and will be held in Brussels, on 17 February 2005, in the presence of Commissioner Margot Wallström, Commissioner for Institutional Relations and Communication Strategy.

The aim the conference is to enable members of national NGOs to come to Brussels, meet with colleagues from across Europe to share experience and ideas on the key issues of ratifying the Constitutional Treaty, the role of NGOs in the process and the further development of participatory democracy at European and national level. It will also provide a space for group discussion on practical issues for NGOs surrounding ratification - e.g. how to campaign in favour, or how to remain neutral but foster debate.

### <u>Study visit to Latvia</u>

The Platform organised a study-visit to Latvia on 25-26 November. The delegation was composed of six people: Fintan Farell (Director of EAPN), Edward Thorpe (AGE), William Lay (COFACE), Anne Williams (EUROCHILD), Juris Lavrikos (ILGA) and Simona de Lisi (platform secretariat). Unfortunately, MHE was not able to participate this time in the visit.

During the visit, the Platform members had the opportunity to strengthen ties with Latvian NGOs, as well as meet with high-level officials of the Latvia government. They introduced the Social Platform and its activities, giving particular emphasis to the Lisbon process and the Social Policy Agenda, as well as their own organisations.

The Latvian representatives gave an overview of the Civil Society situation in Latvia, presenting three case studies from different Latvian organisations.

### Conference "Governance and NGOs of the Future"

The European Economic and Social Committee organised together with the European Policy Forum, a conference on key trends and principles in governance and implications for NGOs in the future.

The meeting brought together international organisations, academics and NGOs to discuss trends in governance and their implications for NGOs of future.

The Conference was introduced by Professor Radaelli, from Exeter University and by José Candela Castillo, Head of Unit Governance, Secretariat General of the European Commission. Comments were given by NGO representatives, Jeremy Hobbs, from Oxfam International and Simon Wilson from the Social Platform.

The NGOs were quite clear in asking for a rights-based approach with increased responsibilities, but with no bigger regulations. A change of strategy with a better collaboration could lead to a stronger governance, with more transparency, accountability, participation and responsibility.

### IV. WORLD HEALTH ORGANIZATION

European Ministerial Conference on Mental Health

This was the first Ministerial Conference on Mental Health ever held by the WHO Regional Office for Europe. The Conference took place in Helsinki, during 12-15 January 2005.

The European Mental Health Declaration and Action Plan was signed by Dr Liisa Hyssälä, the Finnish Minister of Social Affairs and Health, on behalf of all WHO Member States, and Dr Marc Danzon on behalf of WHO. European Commissioner Kyprianou and the Council of Europe representative, Ms Vera Boltho were also present.

The Action Plan proposes ways and means of developing, implementing and reinforcing comprehensive mental health policies in the countries of the WHO European Region, requiring action in 12 areas :

- 1. Promote mental well-being for all ;
- 2. Demonstrate the centrality of mental health ;
- 3. Tackle stigma and discrimination ;
- 4. Promote activities sensitive to vulnerable stages;
- 5. Prevent mental health problems and suicide ;
- 6. Ensure access to good primary care for mental health problems ;
- Offer effective-care in community-based services for people with severe mental health problems;
- 8. Establish partnerships across sectors ;
- 9. Create a sufficient and competent workforce ;
- 10. Establish good mental health information ;
- 11. Provide fair and adequate funding ;
- 12. Evaluate effectiveness and generate new evidence.

It is expected that countries will reflect these policies in their own mental health strategies and plans, to determine what will be delivered over the next five and ten years.

Through the declaration, WHO has committed to several responsibilities in the years to come. We will be active partners, in terms of providing information, research, policy and service development and advocacy.

Dr Marc Danzon said that he found particularly heartening not only the enthusiasm of Member States but also the backing received from the user and family groups, professionals and collaborating centres.

Both plenary and parallel sessions were open to the press.

### V. EUROPEAN UNION NEWS

### Dutch Presidency fails the social NGOs test

The Platform of the European Social NGOs issued a press release on 13 January stating that the Dutch presidency has deceived social NGOs, after doing more to worsen EU social policies than follow its own slogan "Let's Deliver" on a social Europe.

The Dutch presidency was criticised for having failed to anchor issues such as fight against poverty, nondiscrimination and social inclusion to a clear human rights agenda.

"On the Lisbon strategy, the President missed the opportunity to ensure a broad debate about the future of the Lisbon Agenda. The job was left in the hands of the High Level Group led by Wim Kok, working behind close doors, rather than involving citizens. Symbolically, the KoK Group met with the Economic and Financial Affairs Council, but not with the Employment and Social Affairs Council. That shows where they put their priorities" concluded Anne-Sophie Parent, president of the Social Platform.

### Luxembourg EU-Presidency - Priorities

On 1 January 2005, Luxembourg took over the Presidency of the Council of the European Union.

The Presidency attaches particular importance to the new Social Agenda (2006-2010), which the Commission will submit in early 2005 and which will be closely linked to the mid-term review of the Lisbon strategy. Presidency social priorities include more quality employment, healthcare for the elderly and social dimension of Lisbon Strategy, equal treatment when it comes to employment, and the coordination of social security systems.

Moreover, the Luxembourg Presidency will devote a great deal of attention to the proposal for an "integrated action programme in the area of education and lifelong learning" during the first half of 2005. Particular stress will be laid on the issue of integrated learning of a subject and a language.

The Presidency will suggest also adopting resolution on new perspectives for consulting young people (participation in consultative democracy) and awareness raising campaigns for young people to prepare them for their role as citizens.

Concerning reserch, the development of measures to facilitate and favour the mobility of researchers and to clarify their status, as well as the stepping up of nanotechnology-related activities, will be given due attention.

### VI. EUROPEAN COMMISSION

### DG HEALTH AND CONSUMER PROTECTION

<u>Commissioner Kyprianou – WHO Conference on Mental</u> <u>Health</u>

Markos Kyprianou, European Commissioner for Health and Consumer Protection, has called for mental health to be given a higher political priority in Europe.

Speaking ahead of the WHO Ministerial Conference on Mental Health, Mr. Kyprianou called mental illness "Europe's unseen killer" and emphasised his determination that the EU should do more to promote good mental health.

Mr. Kyprianou addressed the closing session of the conference on 14 January and attended the signing of the Mental Health Declaration for Europe.

Commissioner Kyprianou said: "Mental illness is just as deadly as physical illnesses like cancer. More Europeans die from suicide each year than are killed in car accidents or as a result of murder. Yet mental health receives surprisingly little attention – you could say mental illness is Europe's unseen killer. I am determined to change that."

The Commission is currently preparing an EU strategy on promoting good mental health.

### Call for Proposals for the Public Health Programme

The Commission has adopted the 2005 Work Plan for the implementation of the Public Health Programme (2003-2008). The Public Health Programme is a key instrument for promoting EU action and financing in this field.

A Call for Proposals was launched on 15 January 2005. The 2005 Call for Proposals is the most important means of implementing the 2005 Work Plan and the main financing instrument for the programme's activities.

On Mental health, the following actions will be supported:

- Scientific support for networking to promote mental health and to prevent mental disorders including harmful stress;
- Promote positive mental health and prevent mental disorders focusing on children, adolescents and young people in settings such as pre-school, school and further educational settings as well in community settings;
- Identify the situation including policies, strengths, weaknesses and challenges in all Member States, including country analyses;
- Develop evidence based practices for effective mental health promotion and prevention of mental disorders, including actions on depression, suicide prevention and prevention

of self harm and substance abuse in children adolescents and young people;

 Special emphasis will be placed on evaluation and evidence of mental health promotion effectiveness.

In order to present the programme's objectives and encourage potential beneficiaries to submit proposals in 2005, the Commission is organising an Information Day on Thursday 3 February 2005 in Luxembourg. For further information :

### **EUROPE AID – CALLS FOR PROPOSALS**

### Five EU Member States taken to court

The European Commission has announced that it will refer five Member States to the European Court of Justice for failing to transpose the Employment Equality Directive.

The Directive, which prohibits discrimination on grounds of age, disability, religion and sexual orientation in employment and vocational training should have been incorporated into national law by December last year.

The five (Austria, Germany, Finland, Greece and Luxembourg) should have implemented the rules – which ban discrimination in employment and vocational training on grounds of age, disability, religion and sexual orientation – more than a year ago. Similar action has already been taken against the same countries for missing the deadline for the Racial Equality Directive, the other key piece of EU antidiscrimination law. <u>Call for information on inhuman and degrading</u> <u>treatment</u>

The European Committee for the Prevention of Torture (CPT) has announced its 2005 regular visits and invites NGOs to provide information on pertinent issues of ill-treatment in places of detention, including psychiatric institutions and social care homes.

The CPT is a body established by the European Convention for the Prevention of Torture and Inhuman or Degrading Treatment or Punishment, that intends to prevent severe forms of ill-treatment.

The Committee has the right to visit, at any time, any place where persons are deprived of their liberty by a public authority. It also has the right to interview in private detained persons, and to enter into contact with anyone else who may be able to provide relevant information.

After each visit, the CPT sends a confidential report containing its conclusions and recommendations to the State concerned. This constitutes the basis for a dialogue between the CPT and the national authorities in order to strengthen the protection of detained persons from ill-treatment. For further information :

"What is the evidence on effectiveness of capacity building of primary health care professionals in the detection, management and outcome of depression?"

This Health Evidence Network (HEN report highlights that there is a substantial opportunity to improve the quality and outcome of primary care for depression.

It argues that clinician education and guidelines, when offered by themselves, are largely ineffective strategies. A near uniform finding of the report was that the improved outcomes of successful strategies are associated with increased healthcare costs.

Improved outcome will require a greater allocation of resources to primary mental health care. Some interventions, such as nurse case management, might be relatively low cost and be easily implemented within many healthcare settings.

Initiated and coordinated by the WHO Regional Office for Europe, HEN is an information service for public health and health care decision-makers in the WHO European Region.
