## **Notes**

#### When to use this form

To register a name change in New Zealand on or after 25 January 2009:

- Your birth must be registered in New Zealand; or
- If your birth is registered outside New Zealand, you must be a New Zealand citizen or entitled, under the Immigration Act 1987, to be in New Zealand indefinitely (e.g. as a permanent resident).

Use this form if you are the person whose name is to be changed and you are aged 18 or older, or you are under 18 and are, or have been, married, in a civil union or de facto relationship.

If you have any problems filling in this form contact Births, Deaths and Marriages or consult your legal adviser.

#### Other name change forms:

Name Change by Statutory Declaration of person aged under 18 who has not been married, in a civil union or de facto relationship (form BDM 122).

- For changing the names of a person whose birth is registered in New Zealand, who is 2 years of age or older but younger than 18 years of age, and who has never been married, in a civil union or de facto relationship; or
- For changing the names of a person whose birth is registered outside New Zealand, who is a New Zealand citizen or entitled, under the Immigration Act 1987, to be in New Zealand indefinitely, who is younger than 18 years of age, and who has never been married, in a civil union or de facto relationship.

Request for Name Change Within 2 Years of Birth (form BDM 36).

• For births registered in New Zealand where the person is under 2 years of age.

#### Acceptable Evidence to attach to this declaration, if applicable

If your **birth is registered in New Zealand**, you do not need to attach any supporting documents to this application. However, if we cannot find your birth record from the information included in this form, we will contact you for further information.

If your **birth is registered outside of New Zealand**, you must provide a certified true copy or an original of one or more documents providing evidence of the date and place of your birth, and of your status as a New Zealand citizen or person who is entitled, under the Immigration Act 1987, to be in New Zealand indefinitely. Please also include an official English translation of any document that is not in the English language. The following documents are acceptable evidence for this purpose:

- New Zealand Citizenship Certificate; or
- New Zealand Passport (a certified copy of the bio page is sufficient); or
- New Zealand Refugee Travel Document issued under the Passports Act 1992; or
- · Australian Passport or some other evidence of Australian citizenship; or
- Cook Islands. Niue or Tokelau Birth Certificate: or
- Overseas Passport **including the** permanent residence permit or returning resident's visa issued by Immigration New Zealand; or
- Letter from Immigration New Zealand confirming residence or refugee status (if the letter states your name, date and place of birth); or
- Overseas Birth Certificate together with a letter/permit/visa from Immigration New Zealand confirming residence or refugee status; or
- Notorial Certificate (China) together with a letter/permit/visa from Immigration New Zealand confirming residence or refugee status; or
- Household / Family Census Register from an Asian country together with a letter/permit/visa from Immigration New Zealand confirming permanent residence or refugee status.

# Notes (continued)

#### Guidelines about your new name

Your new name (or combination of names) may not be accepted for registration if, in the opinion of the Registrar-General of Births, Deaths and Marriages (or the Family Court on appeal):

- it might cause offence to a reasonable person; or
- it is unreasonably long (that is, it should be less than 100 characters long, including spaces); or
- without adequate justification, it is, includes, or resembles, an official title or rank; or
- it is not a name (for example, it must not consist of or include symbols that cannot meaningfully be expressed in language).

Your new name must consist of one name that is designated to be treated as your surname or family name, and one or more other names, unless your religious or philosophical beliefs, or cultural traditions require you to bear only one name.

Please note that, if you have chosen to assume your spouse's or partner's surname (or a hyphenated combination of both of your surnames) on marriage or civil union, your Copy of Particulars of Marriage/Civil Union or Marriage/Civil Union Certificate may provide sufficient evidence. However, you may choose to complete this form if you want your new surname registered on your birth record (if your birth is registered in New Zealand) or on the name change register (if your birth is registered outside of New Zealand).

If you are married or in a civil union and want to change your first or given names only, then print your new surname as it is currently recorded on your birth registration.

### Certificate showing your new name

#### Birth registered in New Zealand

- If your birth is registered in New Zealand, any new birth certificate that is issued will show the new name as
  well as all previous names. A new birth certificate can be made available after registration, on payment of an
  additional fee.
- Complete and attach a Request for Birth Certificate or Printout Order Form (BDM 93B).

#### Birth not registered in New Zealand

- If your birth is registered outside New Zealand, any new name change certificate that is issued will show the
  new name as well as all previous names registered in New Zealand on or after 25 January 2009.
   A new name change certificate can be made available after registration, on payment of an additional fee.
- Complete and attach a Request for Name Change Certificate or Copy of a Statutory Declaration or Deed Poll Order Form (BDM 93N).
