

# NOTICE TO BIDDERS

## BID BULLETIN No. 1

PROJECT : **SUPPLY AND DELIVERY OF OFFICE FURNITURE FOR CDC RECORDS CENTER**

Pursuant to the queries and discussions made during the pre-bid conference of the project held last September 29, 2005 at Bldg. 2125 OTS Conference Room, hereunder are some modifications and clarifications:

1. **Correction of Dates on the Submission of bids.** The submission of bids and eligibility requirements in item 7, page 3, of the Invitation to Apply for Eligibility and to Bid should be October 11, 2005 at 2:00 pm at OTS Conference Room, Ground Floor, Bldg. 2125, E. Quirino St., CDC Corporate Center, Clark Special Economic Zone, Pampanga. Opening of bids will follow thereafter.
2. **Manufacturer's Authorization Form.** If the Bidder is a manufacturer, the required form and substance of the Form (page 81) should be adopted, with emphasis on the first (manufacturer's name and address) and last paragraph (warranty). The Manufacturer shall also attach thereto a valid Manufacturer's Certificate.
3. **Net Financial Contracting Capacity.** The NFCC should be at least equal to the Approved Budget for the Contract in the amount of Php 469,660.00. The bidder may opt to submit a cash deposit certificate or a credit line as enumerated in Section 13.2 Eligibility Documents item a.8 Section II of the Instructions to Bidders.
4. **Blacklisted Insurance Agency.** The three (3) blacklisted Insurance Agency are as follows:
  - 4.1. Stronghold Insurance
  - 4.2. Sterling Insurance
  - 4.3. Prudential Guarantee and Insurance Corporation
5. **Design of Pushcart.** The design should comply with the prescribed specifications and dimensions stated in the bidding documents.

The above statements shall modify, amend or replace parts of the Bidding Documents and/or other items in the issued bid bulletin.

Pursuant to Section 32.3 of the implementing rules of RA 9184, bidders are prohibited from making any kind of communication with any member of the Committee, the Secretariat or TWG or to follow-up the status of the bid evaluation until after an award has been made.

CDC reserves the right to accept or reject any or all bids; to extend the date of submission and/or opening of bids upon prior notice, if in CDC's opinion there are valid grounds to warrant this; to waive any defect, formality, informality, or technicality in them without affecting the substance of the bids, or to accept such

bids considered, in CDC's opinion, to be most advantageous to the government; and annul the bidding process without offering any reason. The decision of CDC on all matters shall be final. CDC also neither assumes any obligation to compensate nor indemnify the bidders for any expense or loss that may be incurred in connection with this public bidding, nor does CDC guarantee that an award will be made.
