1. **Statement of Availability of Equipment.** The required form is hereby attached for easy reference to be included in the Eligibility (Document) Envelope.
2. **Manpower Requirements.** The said form is hereby attached for inclusion in the Technical Proposal Envelope.
3. **Authorized Signatory.** The authorized signatory should be the one to certify all submitted documents to be authentic reproduction/copies of the original.
4. **Certificate of Good Standing issued by PNP-SAGSD for CY 2002, 2003 & 2004.** The latest certificate issued by PNP-SAGSD at least for the month of September 2005 would suffice in the absence of the required CY 2002, 2003 & 2004.
5. **Total No. of Required Firearms.** The minimum required as stated in the bidding documents will prevail.

The above statements shall modify, amend or replace parts of the Bidding Documents and/or other items in the issued bid bulletin.

Pursuant to Section 32.3 of the implementing rules of RA 9184, bidders are prohibited from making any kind of communication with any member of the Committee, the Secretariat or TWG or to follow-up the status of the bid evaluation until after an award has been made.

CDC reserves the right to accept or reject any or all bids; to extend the date of submission and/or opening of bids upon prior notice, if in CDC's opinion there are valid grounds to warrant this; to waive any defect, formality, informality, or technicality in them without affecting the substance of the bids, or to accept such bids considered, in CDC's opinion, to be most advantageous to the government; and annul the bidding process without offering any reason. The decision of CDC on all matters shall be final. CDC also neither assumes any obligation to compensate nor indemnify the bidders for any expense or loss that may be incurred in connection with this public bidding, nor does CDC guarantee that an award will be made.

- Guards should have attended 2 years in College (with Certification from School) or had at least 72 units in College;
- Guards should not be lower than 5'6" in height;
- The Agency must have at least twenty (20) relievers for this Sector
- Must replace yearly at least fifty percent of the total battery packs of its hand-held radios with brand new ones
- MC units must use motorcycles in patrolling
- MC units must possess valid drivers licenses;
- Guards on posts must have hand-held radios and chargers with spare batteries;
- Guards posted at the CSEZ Gates must not be over 40 years old and should have equipment such as under chassis mirrors for inspecting vehicles
- Guards posted on Pedestrian Lane/Corporate Offices must be equipped with metal detectors.
- Must have own set of handcuff, baton, flashlight & raincoat;
- Must have at least five (5) guards with valid NTC License for Radio Controllers
