Our Internal Complaints Process specifies a Decision notice, including a suggested resolution and reasons for that resolution, is sent to you within 15 working days of the Complaint Acknowledgement notice.

If you do not receive a response to your complaint with 90 days OR are unhappy with the suggested resolution, you may contact the Financial Dispute Resolution (FDR) scheme of which we are members. The FDR is independent, privately owned and Government approved. There is no cost to you for approaching the FDR or utilising the service provided by the FDR, all costs are paid for by the scheme member (e.g. NZ Forestry & Land Investments Limited).
