

Tips for using the Credit-Sale Contract Indemnity Fund fillable form.

This form can be filed electronically **only** if money is **NOT** owed.

If you owe money, please **do not** submit this form electronically. However, you can complete the form, print it and submit it with your remittance check via US mail.

When entering the figure for the Value of Grain Purchased by Credit-Sale Contract During Quarter, **do not use commas**. The form will automatically enter commas once you tab out of the field.

Once the Value of Grain Purchased field is filled in, the computer will automatically calculate and complete the Remittance to the PSC Amount field. The computer will round the figure when you tab to the next field.

Typed signatures are acceptable.

4<sup>th</sup> quarter ends December 31; remittance due January 30.

This report must be completed and returned, even if no grain purchases were made via credit-sale contract during the quarter.
