# Bylaw No. 3023

# A Bylaw to Regulate the use of Highways

The Council of the City of Chilliwack in open meeting assembled enacts as follows:

## CITATION

1. This Bylaw may be cited as "Highway and Traffic Bylaw 2004, No. 3023".

## REPEAL

2. "Highway and Traffic Bylaw 1996, No. 2344" and amendments thereto are hereby repealed.

## **INTERPRETATION**

- **3.** In this Bylaw:
  - "boulevard" means the area between the curb lines, the lateral lines or the shoulder of a roadway and the adjacent property line;
  - "Bylaw Enforcement Officer" means a person appointed by Council as a Bylaw Enforcement Officer for the City of Chilliwack and includes a Traffic Warden;
  - "Chief of Police" means the senior member of the Royal Canadian Mounted Police in the City of Chilliwack or designate;

"City" means the City of Chilliwack;

- "combination of vehicles" means a combination of motor vehicle and trailer or motor vehicle and trailers;
- "Council" means the Council of the City of Chilliwack;
- "crosswalk" means a portion of the roadway at an intersection or elsewhere indicated for pedestrian crossing by signs or lines or other markings on the road surface;
- "cycle" means a device having any number of wheels that is propelled by human power and on which a person may ride;
- "cycle path" means that portion of a highway that is designated for use by cyclists and which is adjacent and parallel to the highway and separated from it by means of road markings;

"emergency vehicle" means a motor vehicle:

- (a) carrying rescue or first aid equipment where there is an urgent emergency;
- (b) driven by a member of a fire department in the discharge of their duties;
- (c) driven by a peace officer, constable or member of the police branch of Her Majesty's Armed Forces in the discharge of their duties;

#### **INTERPRETATION** (continued)

- "Engineer" means the Director of Engineering and Operations for the City of Chilliwack or person authorized by Council, by name of office or otherwise, to act in the place of the Director;
- "extraordinary traffic" includes carriage of goods or persons over a highway whether in vehicles drawn by animal power or propelled by other means, that in conjunction with the nature or existing condition of the highway is so extraordinary or improper in the quality or quantity of the goods or the number of persons carried, or in the mode or time of use of the highway, or in the speed at which the vehicles are driven or operated, as to, substantially alter or increase the burden imposed on the highway through its proper use by ordinary traffic, and cause damage and expense to the highway beyond what is reasonable or ordinary;
- "highway" means a street, road, lane, bridge, viaduct and any other way open to the use of the public, and includes any adjacent allowance, boulevard or right-of-way;
- "local service call" means the driving or operating of a motor vehicle upon a highway for the purpose of collecting, transporting or delivering goods and merchandise, and includes driving to or from the place of business from which the motor vehicle operates;
- "motor vehicle" means a vehicle designed to be self propelled, except a vehicle operating wholly on fixed rails or tracks;
- "panhandle" means to beg for or ask for money, donations, goods or other things of value, without consideration, whether by spoken, written or printed word or bodily gesture, but does not include soliciting for charitable purposes by an organization with permission to do so from the City;
- "parade" means any assembly or group of pedestrians numbering more than 30, standing, marching or walking upon any highway, or any assembly or group of vehicles numbering more than 10, standing or moving on any highway, except a funeral procession or members and vehicles of Her Majesty's Armed Forces;
- "taxi" means a motor vehicle that is designed to carry not more than 10 persons and that, with its driver, is licensed and operated for hire;
- "tow truck" means a motor vehicle designed, equipped and used exclusively for towing and rendering assistance to motor vehicles experiencing a defect or disability in their means of locomotion;
- "trailer" means any vehicle that is designed to be attached to a motor vehicle to be drawn or propelled by the motor vehicle; and
- "vehicle" means a device in, on or by which a person or thing is or may be transported or drawn on a highway, except a device designed to be moved by human power or used exclusively on stationary rails or tracks.

## APPLICATION

## WHEELCHAIRS EXEMPT

4. This Bylaw shall not apply to the driving or operation of a mechanically propelled

wheelchair or invalid chair when used to transport a physically disabled person.

#### **USE OF ANIMALS**

5. A person riding an animal or driving an animal-drawn vehicle upon a highway has all the rights, and is subject to all the duties, that a driver of a motor vehicle has under this Bylaw.

#### **AUTHORITY OF OFFICERS AND EMPLOYEES**

- 6. Where, pursuant to this Bylaw, an officer or employee of the City is empowered to make an order respecting a matter, that power includes the power to rescind, revoke, amend, or vary the order.
- 7. Council may appoint Bylaw Enforcement Officers to enforce the provisions of this Bylaw and for the purposes of this Bylaw, members of the Chilliwack Detachment of the Royal Canadian Mounted Police are Bylaw Enforcement Officers.
- 8. Every officer and member of the City Fire Department, while in the course of attending upon any fire or emergency, is appointed a Bylaw Enforcement Officer for the purposes of this Bylaw.
- **9.** Every Bylaw Enforcement Officer is authorized to take such course of action as they may deem necessary to regulate and control traffic during times of emergency or where the attendance of emergency equipment is required.

# **USE OF HIGHWAYS**

## SIGNS ON OR OVER HIGHWAY

- **10.** No person shall erect or maintain, or cause to be erected or maintained, a sign, guidepost or other similar device, whether temporary, portable or permanent, on or over a highway except in accordance with this Bylaw.
- 11. Every person wishing to erect a temporary sign on a highway shall make application to the Engineer for a Highway Works Permit as set out in Schedule 1 of this Bylaw and pay the fee set out in that schedule and the Engineer, upon being satisfied that all applicable regulations, terms and conditions have been met, shall issue the permit.
- **12.** Signs, guideposts, or other similar devices erected or maintained in violation of this Bylaw may, at the discretion of the Engineer, be altered, repainted, torn down or removed without compensation to any person for any loss or damage which may result from the action.

## PARADES

- **13.** No person shall hold or participate in a parade on a highway unless a permit has first been obtained pursuant to this Bylaw.
- 14. Every person wishing to hold a parade on a highway shall make application to the Engineer for a Highway Works Permit as set out in Schedule 2 of this Bylaw and pay the fee set out in

that schedule and the Engineer, upon being satisfied that all applicable regulations, terms and conditions have been met, shall issue the permit.

## **CONSTRUCTION**

- **15.** No person shall engage in road or utility construction, maintenance or repair, whether temporary or permanent, on a highway except in accordance with this bylaw.
- **16.** Every person wishing to engage in road or utility construction, maintenance or repair shall make application to the City Engineer for a Highway Works Permit as set out in Schedule 1.

## **TEMPORARY BUSINESS AND SOLICITING**

**<u>15.17.</u>** Council may grant approval to a person, group or organization to:

- (a) operate a business on a temporary basis, on a highway subject to the provisions of the City's Business Licence Bylaw and Zoning Bylaw, in force from time to time; or
- (b) solicit for donations of money or material assistance for charitable or similar purposes subject to the terms and conditions set out in City's Policy Directives, in force from time to time.

#### CONVEYANCES

- **<u>16.18.</u>** No person shall use skateboards, roller skates, roller blades, ice skates, sleighs, skis, snowboards or other similar conveyances on any highway in the prohibited area set out in Schedule 7 of this Bylaw.
- **17.19.** The Engineer may temporarily close any highway or part of it for the purpose of permitting the use of conveyances prohibited under Section 16 and for that purpose may cause traffic control devices to be erected, placed, marked or made temporarily inoperable as the Engineer deems necessary.

# **OBSTRUCTIONS**

**18.20.** No owner or occupier of real property shall allow any obstruction to the line of vision from a highway intersection between the height of 0.5m and 3m above the average height of the crown of a highway and within a 25m radius from the intersection of the centrelines of the highway if the obstruction reduces the sight distance to less than the minimum set out in Schedule 8 of this Bylaw.

## MAINTAIN BOULEVARD AND SIDEWALK

- **19.21.** Every owner or occupier of real property adjacent to a boulevard, sidewalk or public footpath on a highway shall:
  - (a) remove all snow and ice from the sidewalk or public footpath as soon as practicable following a snowfall, icefall or frost within a reasonable time of its deposit, but in any case no later than noon on the day following its deposit; and

(b) keep it clear of all litter, rubbish, debris and unsightly or overgrown vegetation.

# **PROHIBITED USES OF HIGHWAY**

**<u>20.22.</u>** Except as herein provided, no person shall use any highway for the purpose of performing any work or doing any act not associated with the normal use of a highway or which in any way impedes or interferes with traffic or defaces or injures a highway.

23. No person shall perform any work prohibited on a highway unless that person has been issued a permit by the City.

**<u>21.24.</u>** Without limiting the generality of Section 20, no person shall:

- (a) construct or install, or cause to be constructed or installed, any access culvert, bridge, sidewalk or other access on or to any highway except as permitted under this Bylaw;
- (b) make any repairs to a motor vehicle while it is upon any highway other than such temporary repairs as are necessary for the removal of the motor vehicle;
- (c) engage in any sport, amusement, exercise or occupation on any highway which may delay the passage of traffic or cause any obstruction;
- (d) build, construct, place, maintain, occupy or cause to be built, constructed, placed, maintained or occupied, any structure, object, substance, or thing which obstructs the free use of any highway or encroaches upon it;
- (e) lay, construct or reconstruct any highway, or any sidewalk which is on or adjacent to any highway; or
- (f) place, throw, deposit or cause to flow upon any highway or walkway:
  - (i) any noxious, offensive or filthy water or substance;
  - (ii) any refuse, garbage, debris, bottle or container;
  - (iii) any rock, stone, earth or soil; or
  - (iv) any unlicensed or derelict motor vehicle.

(g) engage in panhandling:

- (i) on any highway which causes delay in the passage of traffic;
- (ii) which interferes with safe movement of traffic;

(iii) which causes any obstruction; or

(iv) risks harm to the panhandler themselves.

# **REAL PROPERTY ADJOINING HIGHWAY**

**22.25.** No owner or occupier of real property adjoining a highway shall allow or permit any earth, rock, log, stump, water or other fluid or material, to fall, slide, flow, accumulate or otherwise be deposited from the property upon the highway, or having been so deposited, to remain on it.

# MATERIAL FALLING FROM VEHICLE

**23.26.** Where any article, substance or material becomes loose or detached, or blows, spills or falls from any vehicle on to any highway, it shall be the duty of the driver of the motor vehicle to immediately take all necessary precautions to safeguard traffic and to remove such material from the highway.

## TOW TRUCK OPERATORS

**24.27.** It shall be the responsibility of the driver or operator of a tow truck removing from the highway any motor vehicle damaged in an accident or otherwise, to also remove any dirt, broken glass, metal and debris deposited on the highway as a result of the occurrence.

## NOISE ON HIGHWAY

- **25.28.** No person shall make or create any noise on a highway, whether from a motor vehicle or not, which disturbs or tends to disturb the quiet, peace, rest, enjoyment, comfort or convenience of the neighbourhood, or of persons in the vicinity, or which Council believes is objectionable or liable to disturb the quiet, peace, rest, enjoyment, comfort or convenience of individuals or the public.
- **<u>26.29.</u>** Council may, on application by a person wishing to operate a motor vehicle while using a public address system or other sound producing device, permit such activity on a highway subject to such terms and conditions as Council may prescribe.

## WILLFUL DAMAGE

**<u>27.30.</u>** No person shall deface any highway in any manner or damage, modify, alter or remove any boulevard, tree, shrub, plant, bush, hedge, fence or highway lighting adjacent to any highway.

## **PRIVATE ROADS**

**<u>28.31.</u>** The owner of a private road or highway shall maintain it in a clean, fit and safe condition and shall display suitable thoroughfare signs.

## **TRAFFIC REGULATION**

#### **TRAFFIC CONTROL DEVICES**

- **29.32.** The Engineer may order the erection and placement of traffic control devices upon any highway to give effect to this Bylaw and to the *Motor Vehicle Act*, as amended.
- **<u>30.33.</u>** The Chief of Police may order the erection and placement of temporary traffic control devices upon any highway to give effect to this Bylaw and to the *Motor Vehicle Act*, as amended.
- **<u>31.34.</u>** Except where otherwise directed by a peace officer, a person authorized by a peace officer or a flagperson, every driver of a motor vehicle and every pedestrian shall obey the directions and instructions of a traffic control device.

<u>32.35.</u> No person shall interfere in any way with any traffic control device, whether temporary or permanent, which has been erected or placed pursuant to this Bylaw.

## **TRUCK ROUTES**

**33.36.** No person shall operate a motor vehicle with a gross vehicle weight exceeding 10,000 kg on any highway other than on a highway designated as a City truck route as set out in Schedule 6 of this Bylaw.

<u>34.37.</u> Section 33 of this Bylaw shall not apply to:

- (a) an emergency vehicle;
- (b) a motor vehicle while on a local service call, where the site cannot be reached except by travelling on a portion of highway not designated as a City truck route;
- (c) a motor vehicle lawfully engaged in highway construction or maintenance, including travelling to or from the work site, where the site cannot be reached except by travelling on a portion of highway not designated as a City truck route; or
- (d) a motor vehicle owned or operated by any municipal, provincial or federal government.

## **ENGINE BRAKES**

38. No person shall, except in the case of emergency, use an engine brake of any kind (including a Jacobs brake) to slow or stop a motor vehicle on a highway within the City of Chilliwack boundaries.

## SIZE AND WEIGHT RESTRICTIONS

**35.39.** Except as authorized by permit, in the form attached hereto as Schedule "2" and forming part of this Bylaw, no person shall drive or operate a motor vehicle or combination of vehicles exceeding the permitted limits of dimension, weight, load, drive axles, horsepower and other limits prescribed in the *Commercial Transport Act*, as amended.

## ESCAPING OR INSECURE LOAD

**<u>36.40.</u>** No person shall drive or operate on a highway a motor vehicle or combination of vehicles unless the load is secured in a manner which complies with the requirements of the *Motor Vehicle Act*, as amended.

#### TIRES

**37.41.** No person shall drive or operate on a highway a motor vehicle or combination of vehicles unless equipped with tires which comply with the requirements of the *Motor Vehicle Act Regulation*, as amended.

# WEIGHING

<u>**38.43.**</u> Where directed by a peace officer, the driver of a motor vehicle on a highway shall:

- (a) stop the motor vehicle for the purpose of weighing, measuring or inspecting the whole or part of the vehicle or its load or for any other purpose pursuant to this Bylaw or the *Motor Vehicle Act*, as amended;
- (b) drive the motor vehicle to the nearest public scales for the purpose of weighing the motor vehicle and load; and
- (c) rearrange the load upon the motor vehicle, or remove the whole or part of the load, to comply with this Bylaw or the *Motor Vehicle Act*, as amended, before continuing to drive or operate the motor vehicle.

## WEIGHING (continued)

**39.44.** Where directed by a traffic sign on a highway to drive over scales, the driver of a motor vehicle shall drive to the scales for the purpose of weighing, measuring or inspecting the whole or part of the vehicle or its load or for any other purpose pursuant to this Bylaw or the *Motor Vehicle Act*, as amended.

## PROHIBITED USES OF SIDEWALK

- **40.45.** No person shall ride or drive any motor vehicle, cycle or animal or any other means of conveyance upon or across any sidewalk, walkway, or boulevard, except that a cycle may be ridden on any sidewalk adjacent to the following highways:
  - (a) Vedder Road between Keith Wilson Road and Luckakuck Way.
  - (b) Yale Road from Yale Road West to Alexander Street.

# **SNOW VEHICLES**

**<u>41.46.</u>** No person shall, on any highway or sidewalk, drive, operate or ride a snowmobile or snow vehicle except in times of emergency.

# ANIMALS

<u>42.47.</u> No person shall, on any highway or sidewalk:

- (a) leave any horse or other animal without the horse or animal being tethered in a manner so as to prevent it from running away, or from moving onto the highway in any way, or from obstructing any portion of the highway or sidewalk;
- (b) tie or fasten any horse or other animal to any traffic sign, parking meter, tree or any object which can be pushed or dragged onto a highway or sidewalk; or

(c) ride, lead or drive any horse or other animal unless the horse or animal is being ridden, led or driven under the control of a competent person at all times.

## PEDESTRIAN CROSSINGS

- **43.48.** The Engineer may establish pedestrian crossings upon a highway, and may establish traffic control devices to regulate the use of the pedestrian crossings.
- **<u>44.49.</u>** Where a pedestrian crossing exists across a highway, no pedestrian shall cross the highway at any other place other than at the pedestrian crossing within one block or 200m of the pedestrian crossing, whichever is less.
- **45.50.** Council hereby vests in school children and others engaged in traffic safety with respect to schools, the power to require vehicles to stop at pedestrian crossings or other designated places on a highway pursuant to the *School Act*, as amended, or appointment by the Chief of Police.

## **SPEED LIMITS**

- **<u>46.51.</u>** No person shall drive or operate a motor vehicle or vehicle on a highway, at a rate of speed in excess of:
  - (a) the posted speed limit;
  - (b) 50 km per hour where there is no posted speed limit;
  - (c) the speed limit set out in Schedule 3 of this Bylaw for that highway or portion of it; or
  - (d) 20 km per hour on a lane not exceeding 8m in width.

## WARNING DEVICES

**<u>47.52.</u>** No person shall interfere in any way with any barrier, lamp, sign or any other device lawfully placed upon any highway at or near any excavation, construction or other work.

# EXTRAORDINARY TRAFFIC

- **<u>48.53.</u>** Where, in the opinion of the Engineer, a highway may be damaged by extraordinary traffic the Engineer may regulate, limit or prohibit the use of the highway by the motor vehicle or vehicles constituting the extraordinary traffic.
- **49.54.** Any person to whom Section 48 applies may make application to the Engineer for a Highway Use Permit on the form set out in Schedule 2 of this Bylaw and pay the fee set out in that schedule and in addition, pay a fee to the City as compensation for the damage or expense which may, in the opinion of the Engineer, be caused by the extraordinary traffic and the Engineer, upon being satisfied that all applicable regulations, terms and conditions have been met, shall issue the permit.

# **CONTROLLED USE OF HIGHWAY**

50.55. The Engineer may limit or prohibit the use of any highway, including but not limited to:

- (a) prohibiting the use of or presence on a designated highway, or part of it, by or of a designated vehicle, or type of vehicle, either at all times or at designated times;
- (b) specifying the maximum rate of speed at which any vehicle may travel;
- (c) requiring that any vehicle be preceded or followed, or both, by a pilot car; and
- (d) requiring that any vehicle be driven or operated on certain highways only.
- **<u>51.56.</u>** The Engineer may close to traffic or use, any highway at a time and for a period of time and for classes of traffic or use as in their opinion may be necessary for:
  - (a) construction or protection of a highway or other public work;
  - (b) the protection of persons using the highway; or
  - (c) the enabling of permitted traffic to be handled safely and expeditiously.

#### ACCESS TO HIGHWAY

- **52.57.** No person shall construct or allow to be constructed any access to and from any highway for adjacent real property, or any cattle guard, fence or gate across a highway unless a permit has first been obtained pursuant to this Bylaw.
- **53.58.** Every owner of real property wishing to construct an access to and from a highway, or a cattle guard, fence or gate across a highway, shall make application to the Engineer for a Highway Works Permit on the form set out in Schedule 1 of this Bylaw and pay the fee set out in that schedule and the Engineer, being satisfied that all applicable regulations, terms and conditions have been met, shall issue the permit.

#### **PARKING REGULATION**

#### **DESIGNATED PARKING**

**<u>54.59.</u>** The Engineer may establish the following designated parking stalls and parking zones:

- (a) loading zones, commercial loading zones, passenger zones and bus zones;
- (b) disabled persons parking stalls;
- (c) public parking passes for designated public parking lots; and
- (d) taxi stands.

## STOPPING, STANDING AND PARKING

**55.60.** Unless permitted by a traffic control device, no person shall stop, stand or park a motor vehicle:

- (a) upon any portion of a highway marked for parallel parking, other than between the lines or markings indicating the limits of a single stall, except where a motor vehicle is longer than the length of the parking stall in which case it may occupy no more than two stalls;
- (b) upon any portion of a highway marked for angle parking, other than between the lines or markings indicating the limits of a single stall and within 30 cm of the curb;
- (c) in any passenger zone for a period longer than 5 minutes;
- (d) in any loading zone except while actually engaged in loading or unloading of goods or merchandise and then only for a maximum of 30 minutes;
- (e) in a bus zone;
- (f) in a stall designated for use by a taxi unless the motor vehicle is currently licensed to operate as a taxi;
- (g) in a stall designated for use by physically disabled motorists unless a valid placard issued by the Social Planning and Research Council of British Columbia has been obtained and is displayed in the front windshield of the motor vehicle;
- (h) on a sidewalk or boulevard;
- (i) in front of a public or private driveway;
- (j) within 5m of a fire hydrant;
- (k) on a crosswalk or within 6m of the approach side of a crosswalk, flashing beacon, stop sign or traffic control signal located at the side of a highway;
- (1) within 6m of either side of an entrance to or exit from a hotel, theatre, public meeting place, dance hall, fire hall or playground;
- (m) within 15m of a rail of a railway crossing;
- (n) on a highway for the principal purpose of:
  - (i) displaying the motor vehicle for sale;
  - (ii) advertising, greasing, painting, wrecking, storing or repairing a motor vehicle, except where repairs are necessitated by an emergency; or
  - (iii) displaying signs.
- (o) alongside or opposite a highway excavation or obstruction when such stopping, standing or parking obstructs traffic;

## STOPPING, STANDING AND PARKING (continued)

- (p) on the highway side of a motor vehicle stopped or parked parallel to the curb or side of a highway;
- (q) on a bridge or other elevated structure on a highway, or in a highway tunnel;
- (r) in a manner that obstructs the visibility of a traffic control device;
- (s) on other than the right side of a two-way highway, with the right hand wheels parallel to that side and where there is a curb, within 30 cm of the curb;
- (t) on a cycle path;
- (u) in any lane in such a manner as to leave less than 3.5m of the travelled portion of the lane for the free movement of vehicular traffic;

#### **STOPPING, STANDING AND PARKING** (continued)

- (v) on the paved portion of any highway without curbs where the pavement is 7.3m or less in width;
- (w) with a gross vehicle weight exceeding 5,500 kg on any City public parking lot.

## EXEMPTIONS

**<u>56.61.</u>** Section 55 of this Bylaw shall not apply to:

- (a) an emergency motor vehicle;
- (b) a police motor vehicle;
- (c) a motor vehicle owned or operated by a municipal, provincial or federal government;
- (d) a motor vehicle of a public utility corporation;
- (e) a tow truck;
- (f) a Department of National Defence motor vehicle;
- (g) a motor vehicle used to service equipment in a business premises where it is not possible to service the equipment from another location; and
- (h) an armoured motor vehicle used for picking up or delivering cash and other securities; while the vehicle is actually engaged in definite works of necessity requiring them to be stopped or parked in contravention of this Bylaw and provided that adequate warning flags, cones or lights are used where necessary.

## VEHICLES, TRAILERS AND CYCLES

**<u>57.62.</u>** No person shall stop, stand or park upon any highway:

- (a) any trailer or other vehicle designed for occupancy by persons or for the carriage of goods and merchandise unless it is capable of independent propulsion or is attached to a motor vehicle mechanically capable of towing or pulling it at all times;
- (b) any combination of vehicles, including any towing apparatus, in excess of 18.3m in length;
- (c) any motor vehicle or trailer exceeding a gross vehicle weight of 5,500 kg, where the adjacent real property is zoned "residential" pursuant to the City's Zoning Bylaw, in force from time to time, between 7:00 p.m. and 7:00 a.m. of the following day; and
- (d) any cycle except in an upright position in a stand designated and lawfully placed for such use.

## **REMOVAL OF PARKING TICKETS OR MARKINGS**

58.63. No person shall:

- (a) remove any notice or ticket placed or affixed on a vehicle by a Bylaw Enforcement Officer except the owner or operator of the motor vehicle; or
- (b) remove, obliterate, or otherwise interfere with any marking placed on a vehicle by a Bylaw Enforcement Officer for any purpose relating to this Bylaw.

#### **TIME-LIMIT PARKING**

- **59.64.** No person shall park a motor vehicle in a stall for a period of time greater than the time indicated by the traffic control device governing the stall except where the vehicle is parked in a public parking lot designated for the use of public parking passes and where a valid pass is displayed from the rear-view mirror of the vehicle.
- <u>60.65.</u> Where the time limit for parking in a stall has expired and a person requires further parking, the person may:
  - (a) park the vehicle in another stall located a minimum 50m from the stall vacated, or
  - (b) occupy the same stall a minimum of 30 minutes after the stall is vacated.

#### **TIME-LIMIT PARKING EXEMPTIONS**

**<u>61.66.</u>** The Engineer may exempt any person or organization that the Engineer deems eligible from time restrictions by permitting the person or members of the organization to park in time-limit parking stalls in excess of the posted time.

#### ENFORCEMENT

## **BYLAW VIOLATION NOTICES**

**<u>62.67.</u>** A Bylaw Enforcement Officer may issue a bylaw violation notice in the form substantially set out in Schedule 5 of this Bylaw for any violation of this Bylaw and where required, to attach the notice to a motor vehicle.

**<u>63.68.</u>** A notice issued under Section 64 shall be deemed to be sufficiently served if the notice is signed by the issuing officer and is:

- (a) personally served to the person who is the subject of the notice or is the owner or operator of the motor vehicle, vehicle, chattel or obstruction which is the subject of the notice; or
- (b) placed, affixed or attached to a motor vehicle, vehicle, chattel or obstruction which is the subject of the notice.

## **RESPONSIBILITY OF VEHICLE OWNER**

**<u>64.69.</u>** Where there is a violation of this Bylaw with respect to a motor vehicle, the person registered with the Superintendent of Motor Vehicles as the owner of the vehicle shall be responsible for the violation and any fine or penalty incurred, whether or not they were in care and control of the vehicle at the time the violation occurred.

#### **PAYMENT OF FINE**

- <u>65.70.</u> Payment of a fine for a bylaw violation notice as set out in Schedule 4 of this Bylaw may be made in person at the City Hall, or by depositing the payment together with notice in the mail slot at City Hall, or by mail.
- **<u>66.71.</u>** Where payment of a bylaw violation notice issued pursuant to this Bylaw is received by the City within three working days of the date of issue, the penalty shall be reduced by 50%.

#### **RIGHT TO DISPUTE**

**67.72.** Any person issued a bylaw violation notice pursuant to this Bylaw may appeal to the Bylaw Enforcement Office in writing within three days from the date the notice was issued, and who shall review and decide upon the appeal and the decision shall be final.

#### IMPOUNDING

**68.73.** Where any motor vehicle, vehicle, chattel or obstruction is occupying a highway in violation of this Bylaw, the Bylaw Enforcement Officer may, in addition to or instead of any other power granted under this Bylaw, remove, detain or impound the motor vehicle, vehicle, chattel or obstruction.

# **IMPOUND OF VEHICLES**

- <u>69.74.</u> Where a licensed motor vehicle or vehicle is removed, detained or impounded pursuant to this Bylaw:
  - (a) and is not redeemed by the registered owner within 24 hours of the impoundment, written notice shall be given to the owner of the vehicle at the address shown on the records of the Superintendent of Motor Vehicles advising the owner of the seizure of the vehicle and of the procedure to redeem it; and
  - (b) if the motor vehicle is not claimed within 14 days of receipt of a notice given pursuant to subsection (a), it shall become the property of the City and may be disposed of by the City at its sole discretion.

#### IMPOUND OF CHATTELS AND OBSTRUCTIONS

**70.75.** Any chattel or obstruction removed, detained or impounded pursuant to this Bylaw:

- (a) may be recovered by the owner by paying the fees, costs and expenses set out in Schedule 4 of this Bylaw to the City and presenting the receipt and proof of ownership at the City public works yard or other place of storage as the City may designate, or by paying the contractor for the City at their place of business; and
- (b) if the chattel or obstruction is not claimed by its owner within 30 days of the date of impoundment, it shall become the property of the City and may be disposed of by the City at its sole discretion.

#### SALE OF IMPOUNDED PROPERTY

**<u>71.76.</u>** The proceeds from the sale of any motor vehicle, vehicle, chattel or obstruction impounded pursuant to this Bylaw shall be applied to the cost of selling it and to the fees, costs and expenses incurred by the City or its contractors in impounding it and the balance if any, shall be paid into the general revenue account of the City.

#### **OFFENCE AND PENALTY**

- **72.77.** Every person who violates any provision of this Bylaw, or who allows or permits any act or thing to be done in violation of any provision of this Bylaw, or who neglects to or refrains from doing anything required to be done by any provision of this Bylaw, is guilty of an offence against this Bylaw and each day that a violation continues to exist is deemed to be a separate offence against the Bylaw.
- **73.78.** Every person who commits an offence contrary to the provisions of this bylaw is liable upon summary conviction to a penalty of not more than \$10,000.00 in addition to the costs of the prosecution.
- **74.79.** Not withstanding remedies, penalties and fines specified within this Bylaw, a person in violation of the regulations contained in this Bylaw may be subject to penalties specified in the City of Chilliwack "Municipal Ticket Information Bylaw", in force from time to time.

## SEVERABILITY

**<u>75.80.</u>** If any portion of this Bylaw is held invalid by a Court of competent jurisdiction, then that invalid portion must be severed and the remainder of this Bylaw must be deemed to have been adopted without the severed portion.
