## Terms and Conditions:

**Worker's Compensation Board Coverage:** The Government of Alberta shall provide coverage under the Worker's Compensation Act for the Student/Trainee working on an APPROVED training farm site, EFFECTIVE FOR THE TERM OF THIS REGISTRATION, WHEN SIGNED. The Job-Site Trainer named in this Registration Form is NOT COVERED by the Government of Alberta under Worker's Compensation benefits. Students/trainees who are simultaneously registered under Work Experience with their high school, are eligible for WCB coverage under Department of Education policy. Registered high school students will deal with their supervising teacher for WCB procedures in case of an accident.

This Registration Form, when APPROVED by Alberta Agriculture and Food shall not be construed as a contract of employment or agency between the Student/Trainee and the Government of Alberta. Except for the purpose of Worker's Compensation Coverage, the Student/Trainee is not an employee or agent of the Government of Alberta. This coverage for farm work related accidents will continue for up to 60 days from the achievement of Certification to allow for further registration sign-up.

**Liability Waiver:** The Government of Alberta shall not be liable for any damages including consequential damage, to the equipment or to the farm operation of the farmer caused by Student/Trainee or incurred through the Job-Site Trainer's employment/training of the Student/Trainee. Alberta Agriculture and Food may terminate this registration at any time with notice in writing.

**Privacy:** Information on this form that will identify you, is being collected under the authority of the Freedom of Information and Protection of Privacy Act. Your name, gender, date of birth, address, telephone number and Alberta Student Number will be shared with the Alberta Education Ministry for high school credit transcript information. Your name and address, telephone number and Alberta Student Number will be provided to the colleges at Fairview, Olds, Vermilion and Lethbridge so they can contact you about additional learning opportunities in agriculture.
