Terms & Conditions

AFEF & ASG 2012 - Terms and Conditions governing conference delegate registrations

A. Registration and Delegate Fees

- Asia Future Energy Forum 2012 will be held from 23-24 October. Asia Smart Grid 2012 Conference will be held on 23 October. Delegates may choose to attend any one of these conferences, or both conferences. Please refer to the registration form for conference participation selection.
- The relevant basic fees (Early Bird, Normal, Academic) will apply for individual registrations. Group registration rate (group size of at least 3 participants, from the same company/country, for participation in any of the conference) is available. Please refer to Section E on "Group Registration Rate" for more information.
- •All registrations must be submitted on an official Conference Delegate Registration Form (print or online version). Full details are to be provided where requested. Incomplete submissions may result in a delay in the processing of your registration.
- All rates quoted are in Singapore Dollars. All payment must be made in Singapore Dollars. The prevailing GST rate will apply to all registrations received from Singapore-based companies, institutions or individuals.
- Academic rate applies to full-time teaching staff and students from institutions of higher learning and staff of research institutes. Group discounts are not available for Academic rate registrations.
- Entry into the Conference is subjected to full payment being received by the Conference Organiser. Please refer to Section D "Payment Details" for more information.
- To qualify for Early Bird rates, payment of the applicable delegate fees must be made to the Conference Organiser together with the registration or by 17 August 2012, the deadline for Early Bird registrations. Please refer to Section D "Payment Details" for more information.
- Delegate badges are to be worn at all times when attending the Conference and are not transferable. The Conference Organiser reserves the right to refuse acceptance of any registration without prejudice.

B. Registration Cancellation & Substitution Policy

- Notice of cancellation or substitution (in the event of inability to attend)
 must be given in writing at least 14 working days (by Tuesday, 2 October
 2012) to the Conference Organiser. Failure to notify the Conference
 Organiser of the substitution by this date may result in the replacement
 being barred from entering the Conference.
- No refund of fees will be made for cancellations or non-attendance of the Conference after 2 October 2012. Any refund of fees (subjected to the notification deadline for cancellation as stated above) will be subjected to an administrative fee (50% of the fees payable for Academic Rate, SGD250 for all other rates).

C. Registration Confirmation & Delegate Administration

- All conference registrations submitted via the website or official registration form will receive a written confirmation 24 hours upon receipt.
- Delegate Administration Letters will be provided to each registered delegate at least two weeks before the commencement of the Conference.
 The Letter will provide details of delegate administration for the Conference and will have to be presented at the registration counters for participation verification purposes. Registered delegates who do not receive the letter one week before the Conference, please contact the Conference Organiser.

D. Payment Details

- Early Bird Rate will expire at 6:00PM, 17 August 2012 (Singapore Time). Early Bird Rates will only be accorded to registrations received with FULL PAYMENT by this date. Payment of fees for registrations under Normal Rates has to reach the Conference Organiser by Friday, 12th October 2012.
