ACADEMIC FEES 2012/2013 ACADEMIC YEAR

Registration for the academic year entails a service provision contract between the student and IED Madrid. IED hereby agrees to provide the programme for which the student is accepted during the entire academic year. The student, once he/she has passed the admission examination (or has been notified by IED that said examination has been waived) and registered for the selected programme, hereby agrees to pay the total amount of the corresponding academic fees even in the event of a subsequent decision not to continue making use of the services provided by IED Madrid.

The full amount of the fees for the 2012/2013 academic year is divided into the reservation fee and the tuition fees. The reservation fee shall be paid in full at the time of registration and is the only valid manner of reserving a place in IED programmes. IED reserves the right to refuse admission once all available places in the programme for the current academic year have been filled. The reservation fee must be paid in full and may not be divided into instalments under any circumstances. This amount in tuition fees shall enable selection of up to 60 credits. In the event that extra credits are required due to direct admission from other institutions involving transfer of credits, the cost of said extra credits shall be in accordance with the following table of price per ECTS (which for monetary purposes shall be considered "missing credits"). The student shall be notified of the requirement to take "missing credits" once notification of the same is received from the educational authorities.

Tuition fees may be paid in instalments through the services of the banks which collaborate with IED. Students wishing to finance tuition fees must notify the Administration Department before 30 September. Acceptance of financing by the financial institution is a prerequisite for acceptance of the same by IES Madrid. IED may act as intermediary between the financial institution and the student in the event that financing arranged through banks is refused or cancelled.

The tuition fee payment period ends on 31 October. IED Madrid reserves the right to claim immediate payment without further notice of the full amount of deferred payments set forth in the above paragraphs plus the corresponding default interest in the event of any failure on the part of the student to comply with the established payment schedule.

The student must be up to date with payments in order to take academic tests and examinations, obtain grades, certificates, transfer of academic records, take part in exchange plans with other universities, internships in companies, obtain official qualifications and access the website service.

Failure to attend class, justified or not, shall not exonerate the student from paying fees.

Under special circumstances and on the sole criteria of IED Madrid, students may apply for postponement of the same programme for which they have paid the reservation fee for an inextensible period of one year. IED shall notify the student in writing of the outcome of the application for postponement of reservation.

The student shall have the right to abandon attendance of programmes on prior written notice under the following conditions: students registered for 1st year shall inform IED of abandonment before 30th September, and students in subsequent courses before 1st September.

Said right shall only be applicable to reimbursement of annual tuition fees. Under no circumstances shall the reservation fee be reimbursed.
