- 2. If any liens were shown on the face of the original title, please do one of the following:
 - a. For each lien on the face of the original title submit a lien release on the lienholder's letterhead including motor vehicle/vessel/ATV/ snowmobile make, model, year, vessel length, identification number, owner's name and signature of lienholder, or submit DMV form TA-VT-08 (Lien Release).
 - b. If the liens are still in effect, only the lienholder may apply for a duplicate and MUST sign this application below.
- 3. This form cannot be used to add or remove liens. (Use form TA-VT-19 to add liens.)
- 4. The fee for a duplicate title certificate is:

Motor vehicles: \$28.00

Vessels, ATV's and Snowmobiles: \$15.00

- 5. If there are more than 2 owners, additional applications need to be completed. ALL owners are required to sign for the duplicate title.
- . Duplicate titles will not be issued for vehicles that are more than 15 years old.
