Police Jury Room July 7, 2003 Abbeville, Louisiana

Minutes of a regular meeting of the Vermilion Parish Police Jury held on July 7, 2003 with Mr. Edval Simon, Jr. presiding.

The meeting was called to order by Mr. Simon, who asked that the meeting begin with the Pledge of Allegiance, followed by a moment of silent prayer.

Upon motion of Mr. Ritter Trahan, duly seconded by Mr. Purvis Abshire, and unanimously carried, the reading of the minutes of the June 16, 2003 meeting were dispensed with and were accepted.

President Edval Simon, Jr. read the following announcements:

- (1) The next meeting of the CWPPRA Technical Committee will be held at 9:30 a.m. on July 16, 2003 in Baton Rouge.
- (2) The Louisiana Rural Health Access Program's Summer Conference will be held on July 17, 2003 in Lafayette.
- (3) The Louisiana Floodplain Management Association and St. Mary Parish will sponsor a workshop entitled "Practical Information on the National Flood Insurance Program" on Friday, July 18, 2003 in Patterson.
- (4) Lorman Education Services will sponsor a one-day seminar entitled "Cafeteria Plans 125 / COBRA In Louisiana" to be held on August 19, 2003 in Lafayette.
- (5) Received correspondence from The Port of Iberia acknowledging receipt of the Vermilion Parish Police Jury's conditional support of the Deepwater Access Project.

- (6) Received a notice from the Department of Transportation and Development advising of the award of an asphaltic concrete overlay project of a portion of La. Hwy 82 in the Pecan Island area beginning 7.62 miles east of the Cameron Parish Line and extending eastward up to La. Hwy 3147. This project is anticipated to be completed within 6 months, weather permitting.
- (7) Received correspondence from the State of Louisiana Military Department Office of Homeland Security and Emergency Preparedness advising that in accordance with recently amended Louisiana Revised Statutes, the Louisiana Office of Emergency Preparedness, and other parish, local and interjurisdictional emergency preparedness agencies are to be re-designated as Homeland Security and Emergency Preparedness Agency.
- (8) Received the Vermilion Parish Clerk Of Court's proposed operating budget for the fiscal year beginning July 1, 2003 and ending June 30, 2004, which will be kept on file.
- (9) Received the Parochial Employee's Retirement System's 2002 Audit Report, which will be kept on file.
- (10) Received the Acadiana Criminalistics Laboratory Commission's 2002 Financial Report, which will be kept on file.

Upon motion of Mr. Ritter Trahan, duly seconded by Mr. Louis Joe Hardy, and unanimously carried, the Police Jury approved issuance of the following permits as presented by the Parish Engineer's office:

Upon motion of Mr. Ernal "E. J." Broussard, duly seconded by Mr. Pervis "Pee Wee" Meaux, and unanimously carried, the Police Jury approved the issuance of letters of no objection relative to the following projects:

- (C) A letter of no objection to ExxonMobil Production Company to clean out existing man-mad canal system to access existing well sites and facilities in the Pecan Island Field in Election District No. 13.

Upon motion of Mr. Hubert Faulk, duly seconded by Mr. Minos Broussard, and unanimously carried, Item No. 15 of the Public Road Committee Recommendations was amended to add the following driveway permit installations:

Upon motion of Mr. Luther "Buster" Hardee, duly seconded by Mr. Ritter Trahan, and unanimously carried, the Public Road Committee Recommendations were approved as amended, and the appropriate officials of the Jury were authorized to carry out the recommendations:

AS A RESULT OF A PUBLIC ROAD COMMITTEE MEETING HELD ON JULY 2, 2003, THE FOLLOWING ITEMS ARE RESPECTFULLY SUBMITTED FOR THE JURY'S CONSIDERATION: INCLUDES ACTIONS FOR OTHER PROGRAMS

- 1. It is recommended that the temporary construction "No Wake Zone" in the Boston Canal not be renewed at this time.
- 2. It is recommended that Invoice No. 006364 from Sellers & Associates, Inc. in the amount of \$5,620.00be approved to be paid. Invoice represents engineering services provided relative to the Boston Canal Project:

- 5. It is recommended that the award of the material supply contract to furnish asphaltic concrete, which was awarded to Diamond "B" at the June 16, 2003 meeting, be rescinded in view of them not having an asphalt plant within 30 miles of Vermilion Parish as specified.

It is further recommended that the remaining bid be rejected and the Road Supervisor and Purchasing Agent be authorized to obtain quotes from contractors on an as needed basis.

Nomination to be submitted to the Acadiana Legislative delegation for appointment.
- 17. It is recommended that the Invoice dated June 26, 2003 from Utility Cost Control in the amount of \$390.26 be approved to be paid. Invoice represents payment of audit fees associated with refunds obtained on electrical service charges.
- 18. It is recommended that The Sellers Group be authorized to advertise for bids to be received for the re-roofing of the original building roof at the law enforcement center.
- 19. It is recommended that the following road right-of-ways be accepted into the road maintenance system in view of documents have been provided:
 - A) Baylee Road Extension E.D. #2
 - B) Lakeshore Road Extension E. D. #14
- 20. It is recommended that the Police Jury enter into an intergovernmental agreement with the Coulee Kinney Drainage District to repair a culvert crossing in the area of the Wilson Boudreaux property. Police Jury to provide labor and equipment to do the work.
- 21. It is recommended that the Police Jury declare as surplus and advertise for bids to be received for the sale of the old mobile home formerly used as the Area 3 Satellite Barn.

- 22. It is recommended that the Police Jury go on record, regarding the Louisiana Coastal Authority study, requesting the Corp Of Engineers and Department of Natural Resources address the salinity barrier needs of the eastern Mermentau Basin.
- 23. It is recommended that the Police Jury request the State Land Office to establish the boundary line between Iberia and Vermilion Parish as an independent third party.
 - It is further recommended that the Police Jury submit an intergovernmental agreement to the Iberia Parish Government to jointly share in the cost of the boundary line survey, subject to the surveyor selection being mutually agreed upon by both parties.
- 24. It is recommended that a letter be sent to the following persons advising them to discontinue the placing of unused scrap material at the roadside which was hauled to their property from throughout the parish and outside of the parish.

It is recommended that Granger's Quality Welding be awarded the contract to fabricate and install the replacement water control gates for the Magee Canal project at a cost of \$5,900, being the lowest of the three (3) quotes received. Costs to be reimbursed through the Rural Development Grant obtained for this project.
- 26. It is recommended that Sellers and Associates, Inc. be authorized to prepare a C.O.E./Coastal Use Permit application relative to the repairs to levees and breeches in the area of the Leland-Bowman Locks.
- 27. It is recommended that a pauper funeral allocation be authorized for Quenton Thibeaux, Jr. made payable to Vincent Funeral Home.
- 28. It is recommended that the Police Jury enter into an intergovernmental agreement with the Coulee Des Jons Drainage District to clean out a drainage in the Pecan Island area.

O R D I N A N C E 2003-O-10

AN ORDINANCE REGULATING TRAFFIC ON NED LANE A RESIDENTIAL AREA IN THE PARISH OF VERMILION

BE IT ORDAINED by the Vermilion Parish Police Jury in regular session convened on the 7th day of July, 2003:

SECTION 1. There shall be a maximum load limit pertaining to vehicles operating on **Ned Lane** in the Parish of Vermilion of 10 tons (20,000 pounds) with a maximum of 3 axles. All damages and repairs due to failure to comply with the above limits shall be the responsibility of the violating party.

SECTION 2. All vehicles are prohibited from parking on **Ned Lane** and its road right-of-way, except for loading and unloading and occasional guest visit.

SECTION 3. All parish, out of parish, and commercial vehicles which are in the act of providing a service or intended trade, are exempt from the provisions of this ordinance.

SECTION 4. All ordinances or parts of ordinances in conflict, herewith are hereby repealed.

Upon motion of Mr. Mark Poche', duly seconded by Mr. Kenneth DeHart, and unanimously carried, the Police Jury did proclaim the following:

The Secretary-Treasurer advised the Jurors of the Project Plan Meeting to develop a Hazard Mitigation Plan to be held on July 14, 2003 from 1:30 p.m. to 3:30 p.m. in the Police Jury Meeting Room.

The Secretary-Treasurer advised the Police Jury that notification had been received from the Division of Administration Community Development Office of the award of grants for the extension of the North Vermilion Water Distribution Area-VII (Indian Bayou Area) and the extension of the waterline in Area VIII (Forked Island Area). The contract amounts are \$599,219.00 for the North Vermilion Area VII and \$389,755.00 for the Forked Island Area-VIII.

Regarding the Iberia-Vermilion Boundary Line dispute, Legal Counsel, Paul Moresi, III, advised the Police Jury that the Iberia Parish Council has adopted a resolution to ask the State Land Office to conduct a survey and to also enter into a cooperative agreement with the Vermilion Parish Police Jury to share in the cost of the survey.

Mr. Moresi, also advised the Jury that he had obtained a copy of the Lafayette Parish Noise Ordinance. He will review and make his recommendations to the Jury.

Regarding adjudicated properties to the parish, Mr. Moresi advised the Jury that there are available options by state law to dispose of the property.

Mr. Nick Gautreaux, candidate for State Senator, District 26, introduced himself and outlined his campaign platform.

Mr. John Istre, with Broussard, Poche', Lewis & Breaux, gave a recap of the 2002 Audit Report.

Mr. Charles Foti, candidate for Attorney General, introduced himself and outlined his campaign platform.

Relative to a seismic permit application, Mr. Paul Bourgeois, with Fairfield Industries, requested a waiver of the full time monitor requirement due to the fact that all of the work is to be done offshore. Mr. Bourgeois also advised that air guns are to be used as the energy source, in lieu of dynamite in drill holes.

Upon motion of Mr. Mark Poche', duly seconded by Mr. Ernal "E. J." Broussard, and unanimously carried, relative to the Fairfield Industries Seismic Permit application, the Police Jury waived the requirement for a full time monitor, but required that a monitor would be required to inspect the job site at the beginning of the project, do one or two interim monitorings, and a final monitoring. Fairfield Industries also agrees to provide documentation from a marine biologist already assigned for the project to meet other permit requirements.

Upon motion of Mr. Hubert Faulk, duly seconded by Mr. Minos Broussard, and unanimously carried, the Police Jury approved the hiring of the following CDL Truck Drivers for the Solid Waste Trash Program as recommended by Mr. Ricky LeBlanc:

Upon motion of Mr. Ernal "E. J." Broussard, duly seconded by Mr. Pervis "Pee Wee" Meaux, and unanimously carried, relative to the open position of Commissioner to the Abbeville Harbor & Terminal District effective July 1, 2003, the Police Jury nominated Mr. Tony Turnley to replace the name of Mr. Dallas Dubois, who was nominated at the previous meeting but is unable to be considered due a conflict because of the nature of his employment.
