"BUSINESS" VISA REQUIREMENT

1. One (1) completed application form pasted with a photo (2 photos required)
2. One (1) completed "Work History" form.
3. Business Letter of introduction from the Myanmar Company and U.S. Company on the company letterhead.
4. Prepaid Self-Addressed **FedEx's** Return Envelope.
5. Payment of US\$ 30 (US\$ Thirty only) per applicant for visa fees:

N.B. : Myanmar Embassy assumes no responsibility for any delay of loss in the mail, or while the documents are in the custody of the courier services. The applicant shall note the tracking numbers of all envelopes used and submitted.

(*Applicant can choose any mail service *Avoid use of P.O. Box mailing address)

VISA INFORMATION

- The Business Visa is valid for a stay of 10 weeks.
- Visa is valid for 3 months from the date of issue, which cannot be renewed or refunded.
- The Multiple Journey Entry Business Visa may be obtained for a fee of US\$ 150 at the discretion of the Embassy Official. (N.B. : First time visitors are not eligible to apply MJEV)

Photography Guide (2 photos required)

- The photograph must have been taken within the last six months
- Identical photos must be submitted with the passport application
- The photograph should be in color and must be taken against a white or off-white background.
- **Side or angled views are NOT accepted.**
- The photographs for each visa applicant must be an unmounted, full face photo.
- Photo Size : The photo for each visa applicant submitted must measure : 35 mm x 45 mm.
- Photo Appearance : The Photographs must be a full-face view in which the visa applicant is facing the camera directly.
- Digital Photos : Digitally reproduced photographs must be reproduced without discernible pixels or dot patterns.
