### **Free Family Foundation Gives FLMS \$10,000 Grant to Expand Shoreline Program**

The Free Foundation has given FLMS a grant of \$10,000 to expand its Love Your Lake Cost-Share Program. Each year FLMS contributes a \$2,000 cost-share to help with a public shoreline restoration project. This year the additional funds will allow FLMS to either fund additional or larger projects depending on the proposals received. The deadline for proposals is May 1, see related story below.

## FLMS 'LOVE YOUR LAKE' COST-SHARE PROGRAM

---

The Florida Lake Management Society (FLMS) would like to work with you to help create areas along Florida's lakes that illustrate shoreline management techniques for lakefront owners. Each year FLMS will solicit applications which describe successful shoreline management projects that benefit lakes as well as serve as an educational tool for other lakefront owners in the state. The applications will be reviewed by a selection committee according to the criteria outlined below. FLMS will provide a match of up to \$12,000 (Thanks again to the Free Family Foundation's \$10,000 grant) for expenses incurred by the successful applicant. Expenditures by the applicant can be in the form of labor or monetary contributions. A selection committee organized by FLMS will review and select the project that meets the majority of the criteria rating points. The rating system is as follows:

Criteria	Rating Points
1. Monetary or labor match - Community involvement strategy strongly recommended	0-20
2. Location - Project must be readily accessible to the public	0-20
3. Removal of invasive plants - Establishment of beneficial native plants	0-20
4. Educational signage to explain project	0-20
5. Water Quality Enhancements - Xeriscaping - Irrigation pumping from the lake - Erosion control methods used - Use of environmental swale system	5 points each

The application should include the following: the person or entity performing the project, a one-page description of the proposed project (must include a maintenance plan), address of project, budget for the project, drawing of proposed enhancements (including plants used), and telephone number. Applicants need to also agree to take plenty of before, during restoration and after photographs to provide to FLMS. Deadline for submittal of project proposals is May 1. Projects must be completed no later than September of each year. Shoreline management projects may require permits from the Department of Environmental Protection and/or the Water Management District, as well as one from your local municipality. ### **FLMS 2001 Conference Field Trips and Spouse Tours**

Two Field Trips will be offered to visit local lakes and projects with the experts involved in management, restoration, and protection of these resources. The first field trip will be on Monday May 21<sup>st</sup> departing from the conference hotel at 3:15pm. This trip will include an overview of the Lake Munson restoration project and visits to associated restoration sites. The trip will then “follow the water” south into the Woodville Karst Plain to view sinkhole features and Wakulla Springs. At Wakulla Springs State Park, a Jungle Boat tour of the spring run will help participants whet their appetite for the trip’s grand finale – dinner at the historic Wakulla Springs Lodge. Wakulla Springs State Park is a generous sponsor of this trip.

The second Field Trip will be on Thursday May 24<sup>th</sup> departing from the conference hotel at 2:30pm. The trip will begin at Lake Ella, the first system in Florida to use alum for stormwater treatment, and will proceed to the Lake Jackson watershed to see the various stormwater retrofit projects that have been implemented to restore one of Florida’s few freshwater Aquatic Preserves. If weather and water level conditions are favorable, the next stop will be at Porter Hole sink to view the “sink that drained the lake”. The trip will proceed north over the Ochlockonee River to the famous Nicholson Farmhouse Restaurant for a memorable steak dinner.

The cost of the field trips is \$30 for conference registrants and their guests. The price covers all costs including transportation, dinner, entry fees and tips. A cash bar will be available at Wakulla Springs and beer and wine will be provided at Nicholson’s Farmhouse.

Participation in the field trips is limited – space will be reserved on field trips when payment is received with the conference registration on a first come, first served basis. Participants should wear casual, comfortable clothes that can get muddy; however, strenuous walking will not be required. Field trips will not be cancelled due to weather conditions, but the itineraries may be altered as necessary.

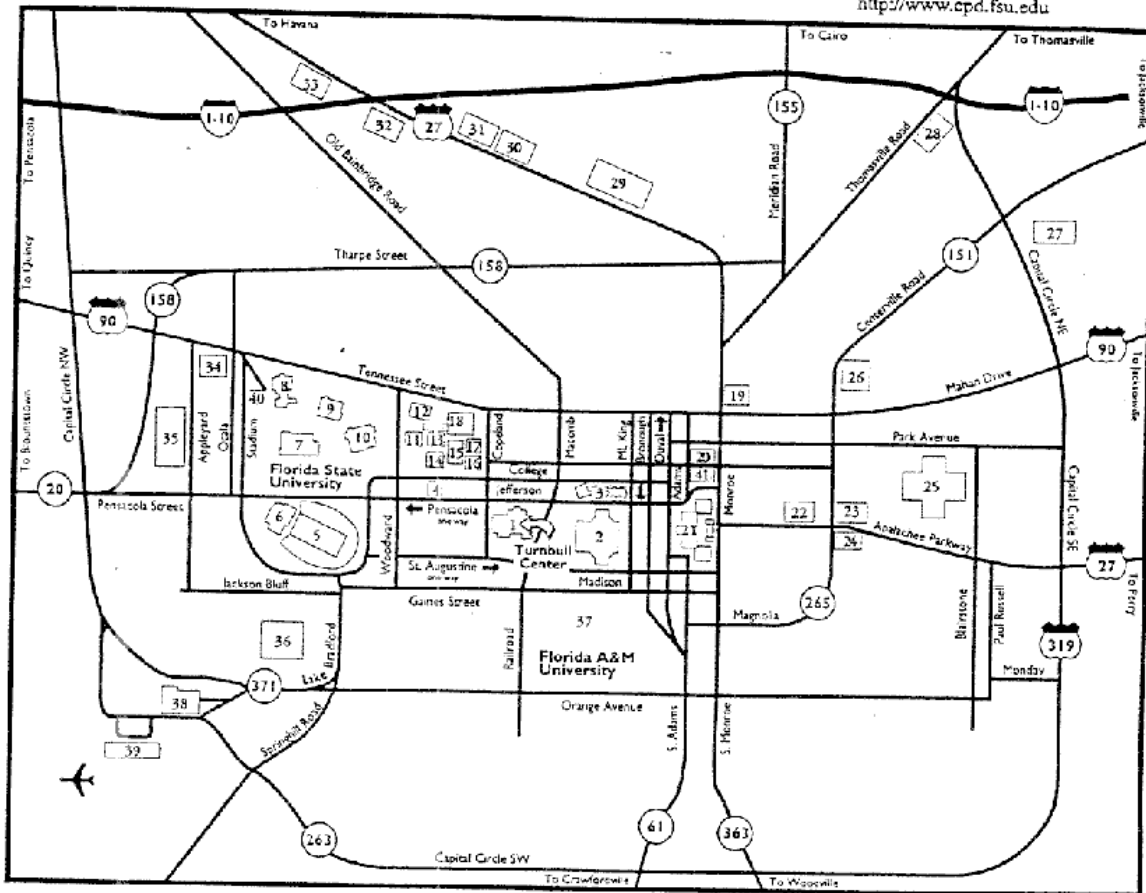
A local tour company will also offer guided spouse tours. These trips will depart the conference hotel at 9:00 am on Tuesday May 22<sup>nd</sup> and Wednesday May 23<sup>rd</sup>. The tour on Tuesday the 22<sup>nd</sup> titled “Historic Plantations, Antiques and Art” will include visits to local plantations and a picnic lunch, topped off by an afternoon of free time to visit the unique shops and galleries of the nearby Town of Havana. The tour on Wednesday the 23<sup>rd</sup> is titled “Historic Governments of the Region” and will include visits to the Museum of Florida History and government sites in the area dating back as far as 900AD, with lunch at a local art gallery. Cost of the tours is \$55 on Tuesday and \$45 on Wednesday, and includes lunch and entry fees.
