## **Associations**

Callcredit

When people live together as couples, whether married or not, their earning and spending behaviour almost always have an effect on each other. Lenders collect information on those financial relationships when consumers make applications for credit. Credit reference agencies hold that information in the form of 'associations' to record financial links between people, so that lenders can consider a full picture of their finances.

However, sometimes people who are no longer (or never have been) linked find themselves connected in this way. Examples might be members of the same family, flat sharers or students sharing a dwelling on a temporary or short-term basis, or couples following a relationship breakdown, such as a divorce.

Disassociations enable you to tell us about your circumstances and ensure that our current records are accurate and up to date.
