completing a W-8BEN form for an individual

Please complete this form to buy shares listed in the United States, and to receive dividends and interest from US and Canadian shares at reduced rates of tax.

This form is for investors who are not US persons. If you are classed as a US person, please see www.hl.co.uk/usshares for further information.

Your W8-BEN form is valid for three calendar years after the year in which it is signed. We will contact you when your form nears expiry.

If you are filling in this form in relation to a bare trust account, please complete in the name of the beneficiary of the trust, and submit with form W-8IMY and a Withholding Statement, both in the name of the trust.

Please ensure you return the original form containing a “wet” signature – we cannot accept photocopies or computer-printed signatures.
