- Locally Employed Civilians who have no CAT 5 clearance will be required to complete a BFG Form 28(A) and produce a Police Clearance
 Certificate, and a copy of their Personal ID Card or Passport.
- Civilians not working for the Forces in Germany and require regular access to Elmpt ranges must complete BFG Form 28(A), and submit a
 Police Clearance Certificate, together with a copy of their Personal ID Card or Passport.

RETENTION OF SECURITY CHECK DATA

Data gathered in connection with security checks is processed in Germany and is not shared with other British agencies or third parties. Security check results are provided only to the head of command or security officials of the command in charge of the unit or organisation in which the applicant is seeking membership to.
