Treasurer's Report

City Report

Sandy Stokes presented the city report. The Holiday Open House will be held December 9 from 4:00 to 8:00 pm at City Hall, located at 121 Mulberry Street. The Open House will include a Santa for the kids, JD Unplugged. Donations of non-perishable food items or a new unwrapped toy or gift suitable for a senior citizen earns an entry into a drawing for prizes. The city is working on their budget for 2012 and opened bidding for the sewer project.

School District Reports

Chris Gaines, Wright City Schools, detailed two accidents in the district boundaries that affected students. Basketball is in full swing and everyone is anxious for the holiday break.

Kari Monsees, Wentzville Schools, reported they are currently working on the high school plan and nine building additions are going on the district now. The Holiday Assistance Program will benefit 350 families, which means about 1000 kids will have presents to open this year. Netbooks have been distributed to high school freshmen. Montee Ball, a graduate of Timberland High School, is a finalist for the Heisman trophy.

Program

Old Business/New Business

1. Open House: Tim Hooton, president, reminded members to attend the City Open House on Friday. The drawing for the Scholarship Basket will take place there. Many thanks to all members who donated items for the basket and showed support of the Scholarship Fund by donating to the drawing.
2. Scholarship: The Foristell Chamber Scholarship will be awarded for the first time in 2012. Discussion regarding the parameters of the scholarship included age of recipient, minimum GPA requirements, payment strategies, and deadline dates. In order to be eligible, students must be graduating high school seniors or returning college students with a Foristell zip code. The \$500 one time check will be paid to the student upon proof of enrollment. Tim will update the application and have it available at the next meeting.

3. Website: The Chamber web site will offer advertising to members in order to raise money for the scholarship fund. Ads will run from the time a member buys the ad until December 2012 and be priced by size.
