#### Note

This online application is optimized for Internet Explorer version 6 or later and works well with Firefox version 2 or later and Safari version 3 or later.

Late applications will not be processed whitin this call for applications.

Maximum login time per session is 8 hours. Please use the function "Spara tillfälligt" (Save temporarily) at the end of the form so that your data is not lost if you are logged out.

Mandatory questions are marked with an asterisk (\*). It is important for the Arts Council that questions are answered directly in the fields, even if an attachment is sent.

Data in the grey areas will be filled in automatically.

Information about the grant can be found on the Arts Councils website. This information may change over time.

#### **APPLICANTS**

Details of the applicant (organization/institution) will be automatically downloaded from your user account. Make sure that the information is correct before you start filling in the application. Any changes must be made in "My contact details" which can be found on the home page when you log in - NOT in this application.

The applicant must be a legal entity.

#### THE APPLICATION RELATES TO

Enter the name of the Swedish organization/institution/group the application concerns. Specify the name/brand name of the group - the name that the organization is known as.

#### **APPENDICES**

A memorandum of understanding shall be attached to the application and must be enclosed. Please include a project plan. To attach files digitally, click "Bifoga Filer" (Attach Files). The file name can be a maximum of 20 characters. If the file name has more than 20 characters, only the first 20 characters of the filename will be used. The files you attach may not exceed a total of 30 MB.

# Submitting the application form

The last page contains a scroll list with three choices - "Spara" (Save)," "Spara tillfälligt" (Save temporarily) and "Avbryt" (Cancel). To submit your application, select "Skicka" (Send) and click "OK". Note that you can save your completed application by choosing "Spara tillfälligt" (Save temporarily) and by then clicking "OK". A saved application can be viewed once again by going to "Mina ärenden" (My cases) on the home page when you have logged in. To cancel the application, select "Avbryt" (Cancel) and then "OK".

After you have selected "Skicka" (Send) and clicked "OK", step 1 of 3 then starts. You must complete all three steps for your application to be submitted correctly. In step 3, you will receive your case number. It is important that you do not close the window until you have received this confirmation. In step 3, an automated e-mail message is also sent to the contact person responsible for the application, it includes your case number and your application in PDF format.
