- 1. Please find attached a notice as contemplated in Section 129 of the Act, informing you of my appointment as Business Rescue Practitioner for LC Golf SA (COR 123.2).
- 2. Notice of first meeting of affected parties in terms of Section 147 of the Act (**Notice of 1**st **meeting**).
- 3. An agenda for the above-mentioned meeting in terms of Section 147 of the Act is also attached (Agenda).
