MEMBERSHIP FEES - SEE EXPIRY DATE ON MEMBERSHIP CARD

According to the new Firearms Control Act a hunter should, if he wants to register as a Dedicated Hunter, be a member of an accredited hunters association before he can obtain such status. Furthermore this hunter should stay a member of the accredited hunters association, if he/she wishes to keep that status. It is required from the management of the Association to submit the names of the non paid-up members who enjoy dedicated hunter status, to the authorities. This step can lead to unnecessary repercussions, so it will be in your best interest to pay your membership fees promptly on your renewal date. Please note that we will not send invoices, only a reminder. If you wish to receive an invoice, please inform us immediately. Your membership fees can be paid in several ways, but we would like to invite you to make use of the debit order system, in order to make it easier for both yourself and the Association. Use above form for debit order or credit card payments as well as any updating of personal information. Branch changes must be a written request.

VERY IMPORTANT

Remember to use your membership number at all times when making a payment. If you pay per cheque, write your membership number on the back. If you do a direct deposit at the bank, supply your membership number as reference. Remember that it is ultimately the member's responsibility to ensure that the correct information regarding his/her payment reaches this office. If the correct information is not supplied by the member, the office can not take responsibility for late receival of membership cards. Please notify the office of any changes regarding your address and telephone numbers. Cancellation of membership: If membership fees are not paid within 60 days after the expiry date, the membership will be cancelled. This will result in re-applying for membership and payment of the joining fee (currently R350) Membership fees are payable on the expiry date and it will be appreciated if this date is adhered to. Please note: The onus wil rest on the main member to ensure that the family membership fees are paid, as they will not receive a reminder.

Membership fees are currently as follows: R350 per Ordinary member / R150 per Junior or Student member / R110 per Family member
