7. Measurement of work:

ARBITRATION:

- Any dispute or difference of any nature whatsoever, any claim, cross-claim, counter-claim or set off of the COMPANY against the Contractor or regarding any right, liability, act, omission on account of any of the parties hereto arising out of or in relation to his agreement shall be referred to the sole Arbitration of the Managing Director of the COMPANY or of some officer of the COMPANY who shall be nominated by the Managing Director. The Contractor will not be entitled to raise any objection to any such arbitrator on the ground that the arbitrator is an Officer of the COMPANY or that he has dealt with the matters to which the contract relates or that in the course of his duties as an Officer of the COMPANY he had expressed views on all or any other matters in dispute or difference. In the event of the arbitrator to whom the matter is originally referred being transferred or vacating his office or being unable to act for any reason, the Managing Director as aforesaid at the time of such transfer, vacation of office or inability to act may in the discretion of the Managing Director designate another person to act as arbitrator in accordance with the terms of the agreement to the end and intent that the original Arbitrator shall be entitled to continue the arbitration proceedings not withstanding his transfer or vacation or office as an Officer of the COMPANY if the Managing Director does not designate another person to act as arbitrator on such transfer, vacation of Office or inability of original arbitrator. Such persons shall be entitled to proceed with the reference from the point at which it was left by his predecessor. It is also a term of this contract that no person other than the Managing Director or a person nominated by such Managing Director of the COMPANY as aforesaid shall act as arbitrator, hereunder. The award of the arbitrator so appointed shall be final conclusive and binding on all parties to the agreement subject to the provisions of the Arbitration Act, 1940 or any statutory modification or re-enactment thereof any the rules made thereunder for the time being in force shall apply to the arbitration proceedings under this clause.
- b) The award shall be made in writing and published by the Arbitrator within two years after entering upon the reference or within such extended time not exceeding further twelve months as to sole Arbitrator shall by a writing under his own hands appoint. The parties hereto shall be deemed to have irrevocably given their consent to the Arbitrator to make an publish the award within the period referred to hereinabove and shall not be entitled to raise any objection or protest thereto under any circumstances whatsoever.

- d) The parties against whom the arbitration proceedings have been initiated, that is to say, the Respondents in the proceedings, shall be entitled to prefer a cross-claim, counter-claim or set off before the Arbitrator in respect of any matter an issue arising out of or in relation to the Agreement without seeking a formal reference of arbitration to the Managing Director for such counter-claim, cross or set off and the Arbitrator shall be entitled to consider an deal with the same as if the matters arising there from has been referred to him originally and deemed to form part of the reference made by the Managing Director.
- e) The arbitrator shall be at liberty to appoint, if necessary any accountant or engineering or other technical person to assist him and to act by the opinion so taken.

Annexure - III

SCOPE OF WORK

- a) The contractor shall be required to clean any Vegetation growth in the open area of the premises along with Pipe rack & Tracks and also vacant area of the terminal ie rear end of the terminal
- b) The contractor shall be required to cleaning / dusting / sweeping the floors , windows , table and chair , filing cabinet , almirah daily .
- c) The contractors shall be required to clean the toilets, urinal, wash basin daily.
- d) The contractor shall be required to clean any vegetation and blockage of gutter and rain water pipes on the Roof of building.
- e) The contractor shall be required to clean tank roof including removal of accumulated water, debris, weeds etc. from the roof without damaging the paint.
- f) The contractor shall be required to clean tank pad and remove any debris, vegetation etc. from the same.
- g) The contractor shall be required to clean all roads inside the terminal and remove any debris, vegetation, dry leaves etc from the same.
- h) The contractor shall be required to clean and clear all surface drains & drain out any accumulated water / oily water to storm water drain / OWS system under supervision of engineer-in-charge or his representative.
- i) The contractors shall be required to clean the TLF gantry (including floor, platform & metering assembly) & pumps house with degreasing agent.
- j) The contractor shall be required to clean the approach road to Terminal and also clean the Truck parking area in front of the Terminal.
- k) The contractors shall be required to clean the pipeline, including the water pipeline, with wet/ dry cloth to remove dust and oil strain.
- I) The contractor shall be required to remove any vegetation growth on the dyke wall and, approach to the tank area and tank manifold.
- m) The contractor shall be required to keep OWS sump clean and maintain desired level of oily water.
- n) The contractor shall be required to clean the manholes, Catch pits, Funnels for collection of water from tank siphon drain & Tank Farm OWS/Storm water valve pits etc from mud, grass, concrete pieces etc. The collected mud shall be spread uniformly around the pit.
- o) The contractor shall be required to detect and locate any leakage to and from the system to the adjacent storm water drain etc using dye etc. However, rectification/repair of the line to stop any such leakage shall not be under the scope of this contract, provided the contractor has not made the damage.
- p) The cleaning of sump shall necessitate drying out the same and taking out all foreign materials, mud etc from the sump. Necessary arrangement for drying out of sump shall be under scope of this contract and no extra payment shall be made for the same.
- g) The contractor shall be required to follow work permit system.
- r) The contractor, for the execution of the contract, shall be required to follow all safety norms.

- s) Supply of all consumables, tools etc necessary for execution of the contract shall be under the scope of the contract.
- t) Associated minor mechanical work shall be carried out by contractor,
- u) The contractor to clean and remove excess earth, grass etc from around the manholes, Collection funnel etc to ensure no flow of rainwater to the manhole. It shall be necessary to make proper slope/drain around the manholes etc to ensure flow of rainwater to the nearest storm water drain.
- v) The contractor shall be required to collect oily water from oil catcher and storm water drains manually and transport the same to ETP / desired location within premises. Equipment required for collection of oily water and suitable arrangement for transporting the same will be under contractor's scope.
- w) If accumulation of oily water in storm water drains or oil catcher is due to improper drainage from tank farm or improper maintenance of oily water level in OWS system, no payment shall be made to the contractor towards collection of same. In such cases, a penal deduction will be made from the outstanding payment due to contractor as decided by Engineer-in-charge.
