### New Framework for Water Management: Sustainability and Your Community's Water (AICP)\*

The state's Sustainable Water Management Initiative (SWMI) is updating the rules for water withdrawal permits. Begun in 2010, SWMI addresses sometimes competing needs for water, including public water supplies and the health of rivers and streams to support fish and other aquatic life. One of the first goals of SWMI was to describe the current condition of stream and river resources statewide. SWMI applies new scientific analysis on the effects of groundwater withdrawals and impervious surfaces to describe this current condition (referred to as Biological Category) for each of 1400 subbasins. MassDEP's Water Management Act (WMA) Program (MGL 21G) will use these categories to assign applications to Permit Review Tiers to protect waterways through flow alteration goals and associated requirements to minimize and mitigate impacts. SWMI also includes a revised Safe Yield methodology limiting the amount of water that can be withdrawn in the 27 major watersheds. This workshop will explain the final SWMI Framework, highlight municipal pilot projects conducted to "test" its application, and outline next steps.

# 2. Planning and Zoning for Medical Marijuana: Is Your Community Ready? (AICP)\*

Massachusetts became the 18th state to legalize medical marijuana, officially enacted as Chapter 369 of the Acts of 2012. The Medical Marijuana Act went into effect on January 1, 2013. This session will provide an overview of the legislation and we will discuss the merits of adopting a local bylaw to regulate where a medical marijuana treatment center may be sited; the merits of enacting a zoning moratorium that would temporarily prohibit issuance of building and occupancy permits; and what is the current status of rules and guidelines for the registration of dispensaries and use of marijuana from the Massachusetts Department of Public Health.

# 3. Zoning for Solar and Update on Solar Industry (AICP)\*

This session will provide an overview on the model bylaws created by the State for large-scale ground-mounted solar photovoltaic installations and small scale solar photovoltaic systems; implementing a solar bylaw and what is required to make an installation work; an update on the current solar photovoltaic arena; tradeoffs and issues with grid systems vs. off-grid systems; and the New Low cost Bi-modal Solar PV systems, and Low cost 100% Solar powered Zero-Energy home. Speakers include the author of the model bylaws; a planning consultant who has assisted Ipswich in adopting a solar bylaw and recently installed solar at her home; and an energy technology consultant well versed in the areas of solar electric, wind turbine, hybrid vehicle, biofuels, energy storage, hydrogen, and fuel cell fields.

This session will explore some examples of how municipalities have addressed this challenge through the use of Community Preservation Act funds as a catalyst to hire staff as well as undertake affordable housing preservation and production. The lessons learned here will be useful regardless of whether your community has adopted CPA or is looking for reasons to do so in the future.

### 7. Water Infrastructure Finance: Filling the Gap in Funding Water Supply and Wastewater Systems (AICP)\*

Massachusetts has over 20,000 miles of sewage and 21,000 miles of water piping, most of which was installed over 50 years ago. Our water infrastructure needs increased investment to continue to deliver reliable clean water and keep wastes and toxic chemicals out of our environment without service interruptions. At the same time, sources of revenue for these needed investments are declining at the federal, state and municipal level. The result is a large and growing gap—estimated at \$21.4 billion over the next 20 years—between current funding for the state's water infrastructure and wastewater systems and the amount of funding actually needed. The Water Infrastructure Finance Commission was created by the Massachusetts Legislature in 2009 to analyze the needs and develop recommendations for financing going forward. This workshop will review the findings of the Commission and next steps toward addressing the finance gap.

# 10. Town-wide Planning Retreats as a Framework for Master Plan Implementation (AICP)\*

Town-wide comprehensive planning can be very effective at setting out a shared community vision, but municipalities have varying levels of success on identifying specific action/implementation items and building them into a work plan. The Town of Westford was recognized with a 2012 MA-APA award for an innovative approach to Master Plan implementation centered on coordinated inter-departmental project management, and town-wide Strategic Planning Retreats in 2011 and 2012. This innovative, practical approach has led to major progress on master plan implementation, and effective public communication of the status of implementation. This session will describe this model and how it can be applied in other communities.

# 13. Hazard Mitigation and Adaptation to Climate Change (AICP)\*

Recent extreme storms including Tropical Storm Irene and Superstorm Sandy have highlighted the need for communities to prepare for increasing intensities of storms and sea level rise. Both inland and coastal communities can apply Green Infrastructure approaches to increase resiliency and reduce the potential impact of flooding events on infrastructure and properties. These techniques also have other benefits for protection of water resources and the environment. The Town of Marshfield is facing difficult choices about how to manage their coastline now and into the future. The Town enlisted UMass Amherst's Masters of Regional Planning program to draft a chapter on Climate Change Adaptation for their new Master Plan. This presentation describes the report findings, including three key recommendations and a matrix of options to address the range of issues the changing climate brings to all town functions.

### **New Options Available (AICP)\***

The Economic Development Bill enacted in August 2012 authorized the creation of Local Infrastructure Development Zones. This flexible new financing mechanism can be enacted through municipal action in cooperation with affected landowners, and offers opportunities for partnership with Mass-Development. The legislation also streamlined the District Improvement Financing (DIF) program, and expanded potential use of the "I-Cubed" (Infrastructure Investment Incentive) program. These new and amended programs offer a broader array of infrastructure financing options than has ever previously existed in Massachusetts. This session will offer practical advice on determining what approach may work, and how to get started.


