## **LatCrit XIV Hotel Accommodations**



Hyatt Regency Bethesda One Bethesda Metro Center Bethesda, MD 20814

The LatCrit XIV Conference Hotel will be the Hyatt Regency Bethesda Hotel in Bethesda, Maryland. A very accessible and comfortable hotel, the 390-room Hyatt Regency Bethesda offers two full-service restaurants, a fitness center, in-room broadband Internet access, and spacious conference facilities. The hotel is located in the heart of Downtown Bethesda, a diverse and lively urban center two miles northwest of Washington, DC, and three miles from American University. Over 200 restaurants, three live theaters, two multiplex cinemas, and several bookstores are within a short walk of the hotel, which is directly above the Bethesda Metro station (Red Line), offering rapid, low-cost and high-frequency rail service to Woodley Park-Adams Morgan (10 mins.); Dupont Circle (15 mins.); the National Mall, White House and U.S. Capitol (20 mins.); and Reagan National Airport (30 mins.).

#### **DISCOUNT GUESTROOM RATE INFORMATION**

We were able to negotiate deeply discounted guestroom rates for a large block of rooms for LatCrit participants. The LatCrit rates are far below (\$40+) the Hyatt's standard guestroom rates. **TO SECURE** A DISCOUNT RATE BEFORE THE LATCRIT BLOCK IS FILLED, IT IS IMPERATIVE TO RESERVE AS EARLY AS POSSIBLE. HOTEL RATES IN METRO WASHINGTON ARE AMONG THE HIGHEST IN THE U.S., SO PLEASE MAKE YOUR RESERVATIONS WITHOUT DELAY TO AVOID HAVING TO PAY A HIGHER RATE.

LatCrit XIV EARLY BIRD Nightly Guestroom Rates at the Hyatt, available for reservations made through Labor Day, September 7, 2009 (as long as LatCrit block has not sold out):

Single or Double Occupancy Guestroom: \$179 for 9/30, 10/1, 10/4; \$169 for 10/2 & 10/3

Triple Occupancy Guestroom: \$214 for all conference nights
Quadruple Occupancy Guestroom: \$239 for all conference nights

Once the Early Bird reservation period has passed, reservation requests for standard single or double occupancy rooms in the LatCrit block will be honored at a \$189 nightly rate only if our block has sold out and the hotel has remaining standard rooms available. Otherwise, reservations will be available at the prevailing market rates. All rates quoted do not include state and local taxes (which currently total 13%) and applicable service or hotel-specific standard fees.

A NOTE ON ACCESSIBILITY: Due to the Hyatt Regency Bethesda's proximity to and relationships with the neighboring National Institutes of Health and Bethesda Naval Hospital, its facilities are highly accessible to persons with disabilities or mobility challenges. The hotel is holding a number of accessible rooms for LatCrit attendees. Please do not delay in making your reservation if you will require an accessible room. The hotel may need to release these rooms to non-LatCrit guests as our room block sells out.

Most LatCrit XIV programming on Saturday, October 3, will take place at WCL. The law school will transport LatCrit XIV participants in shuttle buses between the Bethesda Hyatt Regency and the law school.
