Southern University at New Orleans Department of Business Entrepreneurship Students Win Morehouse College \$20,000 Business Plan Competition

In November 2009, Dr. Louis C. Mancuso, Professor of Marketing, asked his students if any team would like to participate in the Morehouse College \$20,000 Business Plan Competition. Two students, Tonia Simmons-Doakes, Senior-Business Entrepreneurship, and Erica Bilbo, Senior-Business Entrepreneurship, stated that they would participate.

The two ladies developed a project dealing with the need for Section 8 Housing in the Orleans Parish area. Mrs. Simmons-Doakes and Ms. Bilbo created a company entitled Housing Innovations, LLC. They are to purchase two four-

plexes in the New Orleans East Area of New Orleans where they will refurbish the dilapidated housing found in this area. Also, they will be begin working on their Louisiana Real Estate Sales License.

The students worked with their advisor throughout the Christmas Holidays and Mardi Gras. The finalists were announced by the Morehouse College Entrepreneurship Center. The SUNO team was in the top six finalists. The finalist included case studies from the University of Virginia, Clark Atlanta, Howard, Morehouse (2 cases), and SUNO.

On the day of the finals over 200 people were present and 9 judges from around the country evaluated the participants. On Friday, February 26, 2010 during the Luncheon, the SUNO team won first place with Howard being named second and the University of Virginia third.
