WARNING LETTER

Re: Reference number KY09081-AC

Dear Sir or Madam:

Why You Are Receiving This Letter

We believe that you violated the Horse Protection Act (15 U.S.C. § 1821 et seq.) (HPA), as described in the attached Warning Letter. Our agency, the Animal and Plant Health Inspection Service (APHIS), is responsible for enforcing the HPA, and other agriculture laws, to protect American agriculture from plant pests and animal diseases, and to ensure the welfare of animals.


We may, after providing you with opportunity for a hearing, impose civil penalties of up to \$2,200, or other sanctions for the violations described in the Warning Letter. Though we usually pursue penalties for the types of violations described in the Warning Letter, we have decided not to pursue penalties for these violations so long as you comply, in the future, with laws that APHIS enforces involving animal and plant health.

Consequences of Continuing Non-Compliance

If you violate laws that APHIS enforces in the future, we may pursue criminal penalties, or may pursue civil penalties for the violations described in the attached Warning Letter, in addition to any penalties we may pursue for any future violations.

Since violations of the regulations can have serious and costly impacts detrimental to the public interest, you are warned of this violation. Any further violation of these federal requirements may result in the assessment of a civil penalty or criminal prosecution.
