#### **3**When you are age 65 or over and you do not have Medicare

• Under the FEHB law, we must limit our payments for those benefits you would be entitled to if you had Medicare. And, your physician and hospital must follow Medicare rules and cannot bill you for more than they could bill you if you had Medicare. The following chart has more information about the limits.

## **8**If you...

- Dare age 65 or over, and
- do not have Medicare Part A, Part B, or both; and
- have this Plan as an annuitant or as a former spouse, **or** as a family member of an annuitant or former spouse; and
- are not employed in a position that gives FEHB coverage. (Your employing office can tell you if this applies.)

#### **③**Then, for your inpatient hospital care,

- So the law requires us to base our payment on an amount -- the "equivalent Medicare amount" -- set by Medicare's rules for what Medicare would pay, not on the actual charge;



The exclusions in this section apply to all benefits. Although we may list a specific service as a benefit, we will not cover it unless we determine it is medically necessary to prevent, diagnose, or treat your illness, disease, injury, or condition.

We do not cover the following:

- Services, drugs, or supplies you receive while you are not enrolled in this Plan;
- Services, drugs, or supplies that are not medically necessary;
- Services, drugs, or supplies not required according to accepted standards of medical, dental, or psychiatric practice;
- Experimental or investigational procedures, treatments, drugs or devices;
- Services, drugs, or supplies related to abortions, except when the life of the mother would be endangered if the fetus were carried to term, or when the pregnancy is the result of an act of rape or incest {*plan specific*—*can vary somewhat; discuss with contracts specialist* };
- Services, drugs, or supplies related to sex transformations; or

You must: Write to us within 6 months from the date of our decision; and (a) (b) Send your request to us at: *{{Plan address}};* and Include a statement about why you believe our initial decision was wrong, based on specific (c) benefit provisions in this brochure; and Include copies of documents that support your claim, such as physicians' letters, operative (d) reports, bills, medical records, and explanation of benefits (EOB) forms. **9**2 • We have 30 days from the date we receive your request to: Pay the claim (or, if applicable, arrange for the health care provider to give you the care); or (a) (b) Write to you and maintain our denial -- go to step 4; or Ask you or your provider for more information. If we ask your provider, we will send you a (c) copy of our request—go to step 3. You or your provider must send the information so that we receive it within 60 days of our request. We 3 will then decide within 30 more days. If we do not receive the information within 60 days, we will decide within 30 days of the date the information was due. We will base our decision on the information we already have. We will write to you with our decision. 4 If you do not agree with our decision, you may ask OPM to review it. You must write to OPM within: 90 days after the date of our letter upholding our initial decision; or 120 days after you first wrote to us -- if we did not answer that request in some way within 30 days; or 120 days after we asked for additional information.
