Any time on or after February 4, 2013, Wisconsin Central Ltd. ("WCL") expects to file with the Surface Transportation Board ("STB") a Notice of Exemption seeking authority to abandon a railroad line located between milepost 114.00 and milepost 112.90, a distance of 1.10 miles, in Kaukauna, Outagamie County, Wisconsin. 

ENVIRONMENTAL/HISTORIC REPORT

Wisconsin Central Ltd. ("WCL") submits this Environmental/Historic Report in compliance with the reporting requirements of 49 C.F.R §§ 1105.7 and 1105.8. Supporting correspondence and certifications are attached. It is the conclusion of this Report that the proposed abandonment, if implemented, will not significantly affect either the quality of the human environment or the conservation of energy resources.

ENVIRONMENTAL REPORT - 49 C.F.R. § 1105.7(e)

1 Proposed Action and Alternatives. WCL seeks to abandon its line of railroad extending from milepost 114.00 to the end of track at milepost 112.9 in Kaukauna, Wisconsin (the "Line"). The Line is situated in Outagamie County, Wisconsin and extends a total distance of approximately 1.10 miles.

The Line has not been required to serve any customer in many years. The Line was previously used for general freight traffic. There have been no rail shipments of any kind on the Line in the last two years, and no reasonable possibility for the development of new rail traffic exists.

Following abandonment, WCL intends to salvage rail, ties and track materials from the Line. The railbed and subgrade of the Line will remain in place and not be disturbed.

A map showing the location of the Line is attached herein as **Appendix A**

WCL has contacted and requested comments from the Outagamie County Board. See attached correspondence attached herein as **Appendix B**. WCL has received no comments to date

2. Transportation System WCL does not anticipate that existing regional or local transportation systems or patterns will be affected by the proposed abandonment. No rail service is currently provided on the Line. Thus, no traffic will be diverted to other transportation systems or modes as a result of the proposed abandonment. There is no overhead traffic on the Line, and no passenger trains are operated over the Line.

WCL has contacted and requested comments from the State of Wisconsin, Department of Transportation. See correspondence attached herein as **Appendix C**. The DOT has made no comments to date.

3. Land Use.

(i) WCL does not foresee any inconsistency with regional and/or local land use plans, but has contacted and requested comments from the National Geodetic Survey. See correspondence attached herein as **Appendix D**. The NGS has made no comments to date

(ii) The proposed abandonment lies entirely within the city limits of Kaukauna, Outagamie County, Wisconsin. The Natural Resources Conservation Service has been contacted and comments requested. See correspondence attached herein as **Appendix E**. WCL has received no comments to date.

(iii) This track does not lie within a designated Coastal Zone Management Area and, accordingly, the proposed abandonment will not affect any land or water uses in such an area or result in any coastal impacts. WCL has contacted the Office of Water at the U S

Environmental Protection Agency and the NOAA Office of Ocean and Coastal Resource Management, to determine whether the proposed abandonment is consistent with applicable federal, state and local water quality standards. See correspondence attached hereto as **Appendix F and G respectively**. There have been no comments to date.

(iv) WCL is not aware of any alternative public use under 49 U.S.C. § 10905 for which the remainder of the right-of-way would be suitable.

4. Energy.

(i) The proposed abandonment will not have any effect on the transportation of energy resources. No energy resource commodities move on the Line, and WCL foresees little or no possibility that such on-line traffic would develop in the future.

(ii) The movement and/or recovery of recyclable commodities will not be adversely affected by this abandonment. No such traffic has been handled on this line within the last two years, and WCL foresees little or no possibility that any online recyclable commodity traffic would develop in the future.

(iii) Abandonment will not result in an increase or decrease in overall energy efficiency. There is no freight traffic the Line and thus there will be no changes in existing transportation patterns or energy usage as a result of the proposed abandonment.

(iv) Not applicable. Abandonment of the Line will not cause the diversion of more than 1,000 rail carloads per year or an average of 50 rail carloads per mile per year to motor carriers.

5. Air.

(i) Not applicable. Abandonment will not result in (A) a minimum increase in rail traffic of 100% or eight trains per day on any segment of rail line, (B) an increase in rail

yard activity of at least 100%, or (C) an average increase in truck traffic of more than 10% of the average daily traffic or 50 vehicles per day on any road segment

(ii) Not applicable. Abandonment of the Line will not result in traffic increases which exceed the thresholds specified in 49 C.F.R. § 1105.7(e)(5)(ii)(A), (B) or (C)

(iii) Not applicable. There is no traffic on the Line proposed to be abandoned, thus no shipments of ozone-depleting materials will be diverted as a result of this abandonment

6. Noise. Not applicable. As indicated above, none of the thresholds identified in 49 C.F.R. § 1105.7(e)(5)(i) will be exceeded as a result of the abandonment

7. Safety.

(i) The proposed action will have no adverse effect upon public health or safety. During any salvage operations on the track, precautions will be taken to ensure public safety

(ii) Not applicable. To WCL's knowledge, no hazardous commodities were ever handled on this Line. Accordingly, the proposed abandonment will have no effect on the transportation of hazardous materials.

(iii) To the best of WCL's knowledge, there are no known hazardous waste sites or any hazardous waste materials involved. Therefore, WCL believes that its abandonment will not have any adverse impact on this site.

8. Biological Resources.

(i) The U.S. Fish and Wildlife Service have been contacted and we have requested comments. WCL has received no comments to date. Salvage operations will be handled using existing access routes. WCL thus does not believe that any critical habitat will be

destroyed, altered or affected as a result of the proposed abandonment, or that any endangered or threatened species are present in the area or would be adversely affected. See Appendix II.

(ii) The Line does not pass through or adjacent to any wildlife sanctuaries or refuges or any national or state parks or forests and, accordingly, none will be adversely affected. WCL has contacted and requested comments from the National Park Service. See correspondence attached herein as Appendix I. There has been no response to date.

(iii) WCL contacted and requested comments from Wisconsin Department of Natural Resources. See correspondence attached as Appendix J. WDNR supplied comments in a letter dated October 8, 2012. See correspondence attached as Appendix J-1. While WDNR requests certain actions if the right-of-way is converted to a trail, the environmental impacts (if any) of subsequent trail conversion or other post-abandonment use are not subject to analysis in this abandonment proceeding under the National Environmental Policy Act of 1969, 42 U.S.C. §§ 4321-4343. See, e.g., Iowa Southern R. Co. -- Exemption -- Abandonment, 5 I.C.C.2d 496 (1989), aff'd sub nom Goos v ICC, 911 F.2d 1283 (8th Cir. 1990).

Elsewhere in its comments, WDNR appears to propose that WCL be required to maintain or remove bridges and culverts on the Line. There are no such structures on the Line. In any event, "[t]he Board does not typically require the removal of railroad bridges or other structures when a line is approved for abandonment. . . . [I]t would not be appropriate or consistent with Board precedent for SEA to recommend a condition regarding bridge removal or responsibility for maintenance." Central Oregon & Pacific Railroad, Inc. -- Abandonment and Discontinuance of Service -- In Coos, Douglas and Lane Counties, OR, Docket No. AB-515 (Sub-No. 2) (STB EA served August 15, 2008) at 10. Similarly, WDNR's apparent request that portions of the right-of-way should be "re-graded" or "restored to original grade" does not seek

to address any environmental impact of the proposed abandonment, but rather existing conditions that will be unaltered by abandonment and the salvage of track materials. See Wisconsin Central Ltd. -- Abandonment Exemption -- In Manitowoc County, WI, Docket No AB-303 (Sub-No 39X) (STB EA served June 19, 2012) at 2 (noting in the context of similar WDNR comments that "The board will generally not require mitigation for existing conditions along the rail line or future maintenance of the right-of-way."). WCL thus opposes these elements of WDNR's comments to the extent they seek specific conditions on the proposed abandonment

WCL does not object to WDNR's request that WCL utilize an appropriate erosion control plan during salvage and refrain from placing materials in wetland areas.

9. Water Any water quality effects of the proposed abandonment should be minimal. The Line does not pass over any waterways. WCL does not intend to alter the contour of the roadbed underlying this line in connection with the proposed abandonment. WCL likewise does not anticipate discharge of any materials into navigable waters that would require permits under Sections 402 and 404 of the Clean Water Act.

(i) WCL has contacted the US Environmental Protection Agency to determine whether the proposed abandonment is consistent with applicable federal, state and local water and air quality standards. See correspondence attached herein as **Appendix K**. There have been no comments to date

(ii) WCL also requested comments from the Army Corps of Engineers. See correspondence attached herein as **Appendix L**. There have been no comments to date

10. Proposed Mitigation. As no adverse impact is anticipated, WCL does not propose any mitigation activities


1. Map A map of the Line is attached hereto as **Appendix A**.
2. Description of Line WCL seeks to abandon its line of railroad extending from milepost 114.00 to the end of track at milepost 112.9 in Kaukauna, Wisconsin (the "Line"). The Line is situated in Outagamie County, Wisconsin and extends a total distance of approximately 1.10 miles.
3. Photographs. There are no photographs of this line since there are no structures or bridges.
4. Information on Structures. There are no buildings, structures, or bridges within the proposed Line abandonment.
5. History of Operations The Line was constructed in 1871-1874 by The Appleton and New London Railway Company, a predecessor of the Milwaukee, Lake Shore and Western Railway Company ("MLS&W"), as part of a route between Manitowoc and Appleton, Wisconsin. Chicago & North Western Railway Company ("CNW") acquired MSL&W in 1893. The Line and surrounding CNW trackage was acquired in 1988 by Fox River Valley Railroad Corporation, and in 1993 by Fox Valley & Western Ltd. ("FVW"), a WCL affiliate. FVW was merged into WCL in 2002. The portion of rail line beyond the current end of track at milepost 112.9 was abandoned in 2010. Wisconsin Central Ltd. -- Abandonment Exemption -- In Outagamie County, WI, Docket No. AB-303 (Sub-No. 35X) (STB served December 15, 2009). The Line has not been required to serve any customer in many years. The Line was previously used for general freight traffic.
6. Engineering Documents. If such documents exist, WCL will disclose any documents, or drawings that might be useful in preparation for this abandonment.

7 Historic Criteria There are no structures or bridges located along the Line. WCL believes that no culturally significant locations, archaeological sites or unique landforms will be affected by the abandonment. WCL has contacted and given notice of the proposed abandonment to the Wisconsin Historical Society. See correspondence attached as Appendix M. The Office has agreed that no historic properties are affected. See correspondence attached as Appendix M-1.

8 Ground Disturbances. WCL is unaware of any possibility that archaeological resources may be in the area. The abandonment activities should have no impact as WCL simply intends on removing the rail and ties and leaving the right-of-way intact for possible trail-conversion purposes. Access to the line is generally good.

Thank you for the information regarding the proposed abandonment of the Wisconsin Central Ltd rail line from Milepost 112 9 to Milepost 114.0, in the city of Kaukauna, Outagamie County Department staff has reviewed the proposal and offer comments on the potential impacts of the action on the following areas of concern

1. WATER QUALITY

This section of railway corridor runs along the south side of the Fox River, and is in fairly close proximity to the river. No construction is proposed in the Fox River, but runoff during construction is a concern Please ensure that no sediment or construction debris reach the Fox River during this project Proper erosion control measures must be used and maintained during and after any track, tie, bridge, or culvert removal An erosion control plan should be developed and made part of the project plans and specifications All areas of disturbed soil should be restored to original grade and re-seeded as soon as possible Native species should be used where appropriate.

2 DESIGNATED WETLANDS

The wetlands associated with this section of railway corridor are adjacent to the south shore of the Fox River, and tend to stay fairly tight to the shoreline. The removal of track and ties should not affect any wetlands as they currently exist, provided the abandonment work is kept to the top of the ballast in wetland areas. Do not store or stockpile materials in wetland areas (i e shoreline of Fox River), and any materials incidentally falling into wetlands or waterways should be removed immediately. In general there appears to be enough buffer zone between this section of railway corridor (MP 112.9 to MP 114) and wetland areas, therefore wetlands will not likely be an issue; however, your best efforts should be made to avoid wetland impacts, and the DNR request information on any unavoidable wetland impacts Any work in wetlands may require local, state and/or Corps of Engineers permits

3 100 YEAR FLOODPLAINS

The abandonment itself should have no impact on the 100-year floodplain if no additional fill is placed in the floodplain as a result of the abandonment. If the right-of-way is to be used for transportation or trail purposes, the existing bridges and culverts may remain in place if maintained. However, if this is not the case, all structures must be removed completely and the embankments re-graded and permanently stabilized.

4 ENDANGERED OR THREATENED SPECIES / CRITICAL HABITATS

If the disturbance caused by the track and tie removal is limited to the ballast area only, there should be no adverse impacts to any special-concern species found along the route. However, railroad right-of-ways (ROW) are often found to have rare plants and remnants of prairies occurring along the undisturbed corridor. Prior to ROW conversion to trails or other uses, surveys should be conducted to determine if native grassland savanna, prairie or wet meadow remnants occur along the corridor. If these habitat types are present then rare and endangered species may occur. Additional surveys of these habitat types should be conducted to determine whether rare or endangered species occur. If these species are present, then the remnants should be mapped and the rare species noted. Prior to implementing any actions associated with rail abandonment that may disrupt the ROW or any other development of the area, including staging of equipment, ties and rails, a plan should be developed to avoid or minimize impacts to the remnant habitats and the associated species. If rare species cannot be avoided in the project's impact area, then an incidental take consultation may be conducted to determine if take of the species is allowable.

Any prairie habitat disturbed as a result of the project activities should be reseeded with DNR certified native prairie seed. Every effort should be made to ensure that invasive exotic species are not introduced to the site.

5 WILDLIFE SANCTUARIES OR REFUGES

Railway corridors often provide valuable habitat for native plant and animal species. The Fox River corridor also provides refuge and feeding grounds for various wildlife species. Disturbance due to track and tie removal should be kept to the minimum amount required to do the work, and restored as soon as conditions permit.

6. NATIONAL OR STATE PARKS OR FORESTS

There are no National or State Parks or Forests along the project route.

7 COASTAL ZONE MANAGEMENT

Concerns regarding consistency with Coastal Zone Management would be more appropriately addressed by the Coastal Zone Management Program (608-267-7982) at the Wisconsin Department of Administration, 101 East Wilson Street, Madison, WI 53707.

8. SOIL AND NATURAL RESOURCE CONSERVATION

If the only work done is removal of the ties track, the project should have minimal impact on natural resources along the route. As mentioned previously, proper erosion control measures must be used and maintained during and after the salvage operation, and wetland impacts are to be avoided.

9. REGIONAL AND/OR LOCAL LAND USE PLANS
