To set up YOUR account, YOUR way, contact your local Indiana Farm Bureau Insurance office or our Customer Service Center at 1-800-723-3276 or 317-692-7200.
- 2) **Convenient Payment Options** – You may pre-authorize an automatic withdrawal from your bank account through Electronic Funds Transfer. Or you may mail, phone or make your payment in person at any local Indiana Farm Bureau Insurance office. We accept personal checks or any Visa or MasterCard credit or debit card.
- 3) **Service Fee Charge** – There is never a service fee to our customers who pay the entire premium for the policy term or by Electronic Funds Transfer. If you prefer the convenience of making installment payments, those options are available to you. A \$3.50 service fee charge per account invoice, not per policy, will be assessed when installment payment option is chosen.
- 4) **Late Fee Charge** – There is never a late fee to our customers who pay their invoice by their Payment Due Date. Any payment received after the Payment Due Date will be assessed a \$15.00 late fee.
