#### PRICE:

General - All prices are FOB point of destination designated by ordering agencies and shall include:

<u>Lower Pricing</u> – The State reserves the right to negotiate lower pricing, or to advertise for bids, whichever is in the State's best interest as determined by the Commissioner, in the event of a significant decrease in market price of any product listed.

PPI Price Adjustment — Pricing is firm through October 31, 2007. If requested by the contractor, beginning on November 1, 2007 and then each November 1st thereafter, the originally bid contract prices may be adjusted based on the PPI for "Processed foods and feeds, Bakery products", Not Seasonally Adjusted (Series ID: WPU0211) as published by the US Department of Labor, Bureau of Labor Statistics, Washington D. C. 20212. The maximum allowance for any price adjustment requested for any individual year shall be 5%. The price adjustment is calculated by taking the most recent PPI value in effect for the month of July of the year under consideration and dividing that by the "referenced period": July 2006. The indices are available through the internet at the Bureau of Labor Statistics (BLS) website at "www.bls.gov.com". If at any time, a series ID is discontinued or not available, the State reserves the right to implement another applicable index. PRICE: (Cont'd)

Since there was an increase in the PPI value, all original contract prices will be increased by 4%. In the event the PPI value showed a decrease of more than 1% in the time frame involved, the State shall notify the contractor and the appropriate price reductions shall be implemented.

### Change In Index:

If mutually agreed between the State and the contractor, different index(es) or publication(s) may be used during the contract period and the formula would be adjusted accordingly if required. If the base year for the index changes, a change may be made in the formula if needed. In addition, if mutually agreeable between the State and the contractor, the schedule of dates may be changed.

If price lists were submitted as part of the original bid, the PPI price adjustment clause will not apply to products on these documents. Replacement price lists must be submitted for consideration by the Office of General Services Procurement Services Group. No more than one price list revision will be permitted in a twelve month period.

### **Unworkable Price Structure:**

Should the price structure utilized by the parties become unworkable, detrimental or injurious to the State or result in prices which are not truly reflective of current market conditions, or the price is deemed unreasonable or excessive by the Commissioner, and no adjustment in price is mutually agreeable, the Commissioner reserves the sole right upon 10 days written notice mailed to the contractor to terminate any contract resulting from this bid opening. If the contractor is unable or unwilling to meet contractual requirements in whole or in part based on an unworkable price structure, it shall immediately notify the State of that fact in order that the State may take appropriate action. Such notification shall be in writing and shall be directed to the Office of General Services, Procurement Services Group. Such notification shall not relieve the contractor of its responsibilities under the contract.

### **Limitation:**

Price adjustments are limited to changes as allowed for in this price adjustment clause. Increases in contract costs or prices to compensate for other increases in the cost of doing business, regardless of the cause or nature of such costs to the contractor, will not be allowed during the contract period.

### MINIMUM ORDER

MINIMUM ORDER is \$50.00 per delivery. The \$50.00 minimum is for aggregate total of all products ordered; products may be on more than one purchase order, products may be on more than one invoice.

There shall be no additional charges, fees, delivery costs, etc., for back orders (product previously ordered and not delivered by contractor).

### PURCHASES FROM PRICE LIST:

<u>General</u> - Agencies are to make purchases from the Contractor's PRICE LIST identified in "ADDITIONAL BREAD, ROLLS AND BAKERY ITEMS WHICH MAY BE PURCHASED FROM PRICE LIST" in subitem 1D for Lot I and subitem 1C for Lots II-IV.

<u>Furnishing Price List</u> - At no charge to contract participants, the Contractor will prepare, supply, and keep current for all Authorized Users the PRICE LIST accepted for award.

<u>Addition of Products</u> - Subsequent to award, consideration may be given to the addition of products to the contract as a part of the Price List, if such products are:

- Needed by a client agency;
- Similar to those already awarded, or are of the same product line, or are included in Contractor's Product Catalog.
- Pricing is commensurate with other products already awarded.

If a proposed addition is a product not awarded previously because of pricing or other concerns, it must be clearly demonstrated pricing is reasonable and/or the reason for not awarding previously has been appropriately resolved. Contractor shall not refuse a request from the State to add a product to PRICE LIST if the product is readily available in accordance with the terms and conditions of this award.

### **DELIVERY**:

<u>SERVICE</u> – Delivery shall be made in accordance with instructions on purchase order from each facility. For some facilities, delivery may be required to more than one building. It is anticipated <u>most</u> locations will require delivery to be made at least three alternate days each week (could also be five consecutive days) generally between the hours of 7:00 A.M. and 11:00 A.M.

Deliveries shall be on weekdays except/excluding State holidays. Some locations (Psychiatric and Developmental Facilities) may accept Saturday delivery. Correctional Facilities will <u>not</u> accept Saturday delivery.

The agency and contractor shall agree to a schedule that will ensure a prompt and accurate delivery of items ordered. Deviations from this schedule must be acceptable to both parties.

<u>AGENCY COMPLAINTS</u> – Participating agencies should notify OGS promptly of quality or delivery issues that arise.

DELIVERY: Cont'd

<u>TIME & PURCHASE ORDER INSTRUCTIONS</u> – TIME IS OF THE ESSENCE. The contractor must be prepared to make deliveries as required by instructions on purchase orders.

There shall be no substitution of products ordered without the express authorization of the ordering agency. The ordering agency will not be liable for unauthorized product substitution. Deliveries left on the loading dock without acceptance by the ordering agency shall be considered "abandoned goods" and may be returned at the contractors expense or disposed off at the discretion of the agency.

RESTRICTED DELIVERY – Price includes "restricted" delivery. Delivery to some facilities, particularly Correctional Facilities, have delivery "restricted" - - - delivery must be made during certain hours, generally between 8:30 a.m. to 10:30 a.m. for morning delivery and 12:30 p.m. to 2:30 p.m. for afternoon delivery, and must be made only on weekdays (Monday through Friday) except/excluding State holidays. [It should be noted that correctional facilities occasionally have "lock downs" during which time there is no exit or entry for trucks, etc.]

<u>SITE LOCATION</u> – The site locations listed are <u>NOT</u> intended to be restrictive - - - they identify the specific and <u>general</u> areas and types of locations where delivery will be required. Delivery to other State agencies may also be required even though the sites may not be specifically listed.

<u>PICK-UP/EXCHANGE OF BREAD RACKS</u> – Bread racks, product trays or other containers used by the Contractor for delivery of product to the agency shall be returned or exchanged by the Contractor in a timely manner either at time of delivery, on subsequent deliveries, <u>or</u> as arranged between the Contractor and the ordering agency. **To arrange pick up, agencies should contact the Contractor or call the number below to arrange for them to be picked up: 1-866-492-8729.** 

### CONTRACT PERIOD AND EXTENSIONS:

**General** - It is the intention of the State to enter into a contract for the term as stated herein.

<u>Price Adjustment</u> - Prices shall not be increased through October 31, 2007. Thereafter price adjustment (up <u>OR</u> down) may be made in accordance with provisions in the "PRICE" clause. Price decreases are permitted at any time.

<u>Unilateral Short Term Extension by the State</u> - In the event the replacement contract has not been issued, any contract let and awarded hereunder by the State, may be extended unilaterally by the State for an additional period of up to one month upon notice to the contractor with the same terms and conditions as the original contract including, but not limited to, quantities (prorated for such one month extension), prices, and delivery requirements. With the concurrence of the contractor, the extension may be for a period of up to three months in lieu of one month. However, this extension terminates should the replacement contract be issued in the interim.

<u>Cancellation After October 31, 2007</u> - Either the contractor or the State may unilaterally cancel the contract on a monthly basis any time after the anticipated initial one year period, November 1, 2006 thru October 31, 2007, by providing written notification at least 4 (four) months prior to the effective date of cancellation. (NOTE: The State reserves the right to award a contract to another vendor/bid to replace a contract that may be cancelled.)

<u>Cancellation For Convenience By The State</u> - The State of New York retains the right to cancel contract, in whole or in part without reason provided that the Contractor is given at least sixty (60) days notice of its intent to cancel. This provision should not be understood as waiving the State's right to terminate the contract for cause or stop work immediately for unsatisfactory work, but is supplementary to that provision. Any such cancellation shall have no effect on existing Agency agreements, which are subject to the same 60 day discretionary cancellation or cancellation for cause by the respective user Agencies.

<u>Contract Cancellation</u> - If a contract is cancelled, the State reserves the right to make award on another compliant bid for the original bid letting, but is not obligated to do so; the State is not obligated to hold another bid letting.

### CONTRACT PERIOD AND EXTENSIONS: (Cont'd)

<u>Mutual Extension of Time Period</u> - If mutually agreed between the Procurement Services Group and the contractor, the contract may be extended under the same terms and conditions for an additional period(s) of up to two years; extension may be exercised on a month to month basis such as an additional three month, six month, twelve month, or 24 month period.

#### RESERVATION:

<u>EXIGENCY</u> - The State reserves the right to negotiate, and/or have a solicitation to meet exigencies arising from unforeseen causes at no expense to the contractor where there is an unanticipated need for product or quantity that the contractor is unable to furnish more expeditiously than agreed to under the contract terms.

<u>UNANTICIPATED PURCHASES</u> - The State reserves the right to negotiate lower pricing, or to advertise for bids, any unanticipated excessive purchase. An "unanticipated excessive purchase" is defined as an unexpected order for a contract product(s) totaling more than \$30,000.00

<u>CHANGES IN PROGRAM AND/OR FUNDING</u> - In addition to, and in accordance with, Section 41 of the <u>State Finance Law</u>, the State shall have no liability or obligation to a contractor, supplier, firm or person, if there should be a change in an agency's or a facility's program, operations, responsibilities, funding, staffing, or appropriation, which results in a change in ordering, a change in requirements, a change in contract, a cancellation of contract, etc. The State's past history of ordering, as well as any "forecasts", may not be indicative of ordering in the future.

#### EMERGENCY PURCHASING:

In the event that a disaster emergency is declared by Executive Order under Section 28 of Article 2-B of the Executive Law, or that the Commissioner determines pursuant to his/her authority under Section 163(10)(b) of the State Finance Law that an emergency exists requiring the prompt and immediate delivery of products or services, the Commissioner reserves the right to obtain such products or services from any source, including but not limited to this contract, as the Commissioner in his/her sole discretion determines will meet the needs of such emergency. Contractor shall not be entitled to any claim or lost profits for products or services procured from other sources pursuant to this paragraph.

## **OVERLAPPING CONTRACT ITEMS:**

Products available in the resulting contract may also be available from other State contracts. Agencies are to select the most cost effective procurement alternative that meets their program requirements and to maintain a procurement record documenting the basis for this selection.
