Please remember that all DWI Education Administrators/Instructors must attend at least one DSHS Inservice *within* their 2-year Administrator/Instructor certification period, and Drug Offender Education instructors must *either* attend a DSHS Inservice *or* obtain 20 hours of *DSHS approved* outside continuing education hours within their 2-year certification period. This inservice will meet the criteria for the above named inservice and also provides 16 (for Combined and DOEP) or 10.5 (for DWI Education) CEUs for LPCs and LCDCs. Probation Officers must have their continuing education certificate approved by their chief to obtain hours. TCLEOSE has indicated they will also accept the continuing education hours for peace officers.

This inservice will begin promptly on Monday, June 29 at 8:00 am and will conclude by 12 noon on Wednesday, July 1. In order to obtain credit for this inservice and the certificate of completion, all participants are expected to be on time and complete all sessions *in their entirety*. Vending machines are available for snack purchases, as none will be provided, or you are welcome to bring your own snacks and drinks. We also encourage you to bring a jacket to the inservice, as the temperature in the room may be cool.

Admittance will be based on a first-come-first-serve basis. The cost of the training is \$290.00 for DOEP Inservice (only), \$195.00 for DWIE Inservice (only) or \$320.00 for DOEP & DWIE Combined Inservice. <u>All fees are non-refundable</u>. A late fee will be applied to payments received after the deadline. DO NOT SUBMIT PAYMENT TO DEPARTMENT OF STATE HEALTH SERVICES—please follow the instructions below.

Please complete the Registration Form and submit it to DSHS no later than June 15, 2009. <u>Payments are</u> to be submitted to The University of Texas at Austin along with the attached invoice, no later than June 15, 2009. Once your payment and acceptance form have been received by the appropriate agencies, you are considered enrolled. <u>Absolutely no registrations or payments will be accepted after 5pm on Monday June 22, 2009.</u> If you have questions concerning the inservice, please contact Offender Education at 800-832-9623.
