## Schedule a Wastewater Treatment Plant Tour

Noman M. Cole Jr, Pollution Control Plant 9399 Richmond Highway, Lorton, VA

The Noman M. Cole Jr. Pollution Control Plant offer tours of its wastewater treatment facility to the public during the months of March to July and September to mid November. Tours take approximately two hours and include a half-hour presentation followed by a walking tour. Requests for tours must include detailed information that includes the purpose of the tour and tour group affiliation. In addition, tour groups must accept the following conditions:

- 1. Tour groups must be high school age or older.
- 2. Tour groups composed of high school students must have chaperons.
- 3. All members of the tour group should be comfortable in an outside environment, which includes walking a significant distance traveled in an industrial setting.
- 4. All members of the group must adhere to Noman M. Cole safety requirements and rules of conduct at all times.
- 5. At the discretion of the treatment plant staff, scheduled tours may be canceled at anytime due to weather, construction or other activities.
- 6. Completed Tour Request Forms must be submitted at least one month prior to requested tour date.
